Chair Teichman opened the meeting and remarked to the Committee that there was only two weeks left to work bills and the Committee has a number of bills remaining. She has begun to schedule the bills and it will be a busy two weeks.

The Chair asked for final action on **SB 250–Firefighters health insurance**. This bill covers insurance to be paid for the families of firefighters who have lost their life in the line of duty and have had insurance coverage by their municipality.

The Chair said there had been an informal, open meeting to discuss this bill. As a result, the bill has been amended to pay premiums for the continuation of coverage under COBRA for 18 months. **SB 250** will address firefighters only. (Attachment 1)

The municipality would pay for 18 months of COBRA coverage unless the surviving spouse remarried or reached the age of 65 within the 18 months, or if the surviving spouse has coverage under another policy at their workplace. Only 4 firefighters have died in the line of duty in recent years, so paying the premiums does not seem to be a burden on the municipality.

Senator Steineger moved to accept the balloon and amend the bill. Senator Schmidt seconded and the motion carried.

Senator Steineger moved to pass the bill as amended favorably out of Committee. Senator Olson seconded and the motion carried.

The Chair asked Senator Schmidt to carry the bill on the floor.

The Chair invited Senator Longbine to introduce his pages who were in attendance. They were Gabe Dorsey, Ryan Cahoone, Scott Hazelton, and Clayton Schroer all of Chase County High School.
