1 AN ACT concerning children and minors; relating to juvenile offenders;
2 the revised Kansas juvenile justice code; prohibiting fines, fees and
3 costs from being assessed against a juvenile or a juvenile's parent,
4 guardian or custodian; amending K.S.A. 12-16,119, 20-3129, 28-170,
5 28-170a, 28-176, 38-2306, 38-2312, 38-2315, 38-2317, 38-2328, 38-
6 2331, 38-2346, 38-2348, 38-2360, 38-2361, 38-2362, 38-2369, 38-
7 2373, 38-2384, 38-2389, 38-2396, 38-2399 and 75-724 and K.S.A.
8 2022 Supp. 21-6609, 22-4905 and 28-177 and repealing the existing
9 sections; also repealing K.S.A. 38-2314, 38-2319, 38-2321 and 38-
10 2324 and K.S.A. 2022 Supp. 20-167.

12 *Be it enacted by the Legislature of the State of Kansas:*

13 New Section 1. (a) In any action pursuant to the revised Kansas
14 juvenile justice code, no fines, fees, costs, court expenses, reimbursements
15 or other financial obligations shall be ordered, assessed or sought against a
16 juvenile or a juvenile's parent, guardian or custodian.

17 (b) On and after July 1, 2023:

18 (1) Any outstanding court ordered fines, fees, costs, court expenses,
19 reimbursements or other financial obligations owed by a juvenile or a
20 juvenile's parent, guardian or custodian that were assessed during the
21 course of an action pursuant to the revised Kansas juvenile justice code
22 shall be discharged and shall not be collected.

23 (2) Any juvenile who is participating in an immediate intervention
24 program, on probation, in a juvenile detention facility or juvenile
25 correctional facility or is otherwise being supervised solely because the
26 juvenile has outstanding fines, fees, costs, court expenses, reimbursements
27 or other financial obligations shall be immediately discharged.

28 (3) A juvenile, parent or guardian who is currently incarcerated in a
29 correctional facility, jail, juvenile correctional facility or juvenile detention
30 facility solely because of nonpayment of any fine, fee, cost, court expense,
31 reimbursement or other financial obligation imposed in an action pursuant
32 to the revised Kansas juvenile justice code shall be released from
33 custody.

34 (c) The provisions of this section shall not apply to restitution that is
35 owed by a juvenile.

36 (d) This section shall be a part of and supplemental to the revised

1 Kansas juvenile justice code.

2 Sec. 2. K.S.A. 12-16,119 is hereby amended to read as follows: 12-
3 16,119. (a) Any person convicted or diverted, ~~or adjudicated or diverted~~
4 ~~under a preadjudication program~~, pursuant to K.S.A. 22-2906 et seq.,
5 ~~K.S.A. 38-2346 et seq.~~, or 12-4414 et seq., and amendments thereto, of a
6 misdemeanor or felony contained in chapters 8, 41 or 65 of the Kansas
7 Statutes Annotated, or the Kansas criminal code, and amendments thereto,
8 where fingerprints are required pursuant to K.S.A. 21-2501, and
9 amendments thereto, shall pay a separate court cost if the board of county
10 commissioners or by the governing body of a city, where a city operates a
11 detention facility, votes to adopt such a fee as a booking or processing fee
12 for each complaint.

13 (b) Such fee shall be in addition to and not in substitution for any and
14 all fines and penalties otherwise provided for by law for such offense.

15 (c) Disbursements of these fees shall be to the general fund of the
16 governing body responsible for the funding of the sheriff, police
17 department or countywide law enforcement agency that obtains the
18 fingerprints.

19 (d) Such fee shall not exceed \$45.

20 (e) *Such fee shall not be imposed in any action pursuant to the*
21 *revised Kansas juvenile justice code.*

22 Sec. 3. K.S.A. 20-3129 is hereby amended to read as follows: 20-
23 3129. (a) Subject to the limitations contained in this section, the clerks of
24 the district courts shall tax a library fee in an amount determined by the
25 trustees of the law library in each county for the benefit and account of the
26 law library in each county. Such library fee shall be not less than \$2 nor
27 more than \$10 in all cases commenced pursuant to chapter 60 of the
28 Kansas Statutes Annotated, *and amendments thereto*, and in all felony
29 criminal cases and shall be not less than \$.50 nor more than \$7 in all other
30 cases.

31 (b) The clerks of the district courts in Sedgwick county and Johnson
32 county may tax an additional fee in an amount determined by the trustees
33 of the law library in each county for the benefit and account of the law
34 library in each such county. Such additional library fee shall not be more
35 than \$4 in all cases.

36 (c) The trustee of the law library in each county may increase law
37 library fees under this section once per calendar year as of July 1. Changed
38 law library fees shall be effective as of that date and when filed with the
39 clerk of the supreme court. The trustees of the law library in each county
40 shall file with the respective clerks the fees to be charged in that court.

41 (d) The fees provided for by subsection (a) shall be deducted from the
42 docket fee. The fees provided for by subsection (b) shall be in addition to
43 the docket fees established by law.

1 (e) In criminal cases where the case is dismissed by the state, the
2 county shall be liable for the library fee. Where appeals from conviction in
3 the municipal court are dismissed for want of prosecution, or by the
4 defendant, the state or city shall collect the library fee. Upon failure of the
5 state or city to do so within 90 days after the dismissal, the county from
6 which the appeal is taken shall be liable therefor.

7 (f) The additional library fee under subsection (b) shall be considered
8 a docket fee for purposes of K.S.A. 60-2001 et seq., and amendments
9 thereto.

10 (g) *No fee shall be imposed on or collected from a juvenile or a*
11 *juvenile's parent, guardian or custodian pursuant to this section in any*
12 *action pursuant to the revised Kansas juvenile justice code.*

13 Sec. 4. K.S.A. 2022 Supp. 21-6609 is hereby amended to read as
14 follows: 21-6609. (a) The court or the secretary of corrections may
15 implement a house arrest program for defendants or inmates being
16 sentenced by the court or in the custody of the secretary of corrections or
17 as a sanction for offenders who have failed to comply with the conditions
18 of probation, parole or postrelease supervision, except:

19 (1) No defendant shall be placed by the court under house arrest if
20 found guilty of:

21 (A) Any crime designated as a class A or B felony in article 34 or 35
22 of the Kansas Statutes Annotated, prior to their repeal;

23 (B) ~~subsection (b) of~~ K.S.A. 2022 Supp. 21-5604(b), and
24 amendments thereto;

25 (C) K.S.A. 2022 Supp. 21-5602, and amendments thereto;

26 (D) any off-grid felony; or

27 (E) any nondrug crime ranked in severity levels 1 through 5 or any
28 felony ranked in severity levels 1 through 3 of the drug grid, unless the
29 offender has been sentenced to probation;

30 (2) no inmate shall be placed under house arrest if such inmate's
31 security status is greater than minimum security; or

32 (3) no inmate shall be placed under house arrest who has been denied
33 parole by the prisoner review board within the last six months. Any inmate
34 who, while participating in the house arrest program, is denied parole by
35 the prisoner review board shall be allowed to remain under house arrest
36 until the completion of the sentence or until the inmate is otherwise
37 removed from the program.

38 (b) At the time of placement of an inmate under house arrest, the
39 court, secretary or house arrest staff shall provide written notification to
40 the sheriff and district or county attorney of the county in which any
41 person under house arrest is to be placed and to the chief law enforcement
42 officer of any incorporated city or town in which such person is to be
43 placed of the placement of the person under house arrest within the county

1 or incorporated city or town.

2 (c) House arrest sanctions shall be administered by the court and the
3 secretary of corrections, respectively, through rules and regulations, and
4 may include, but are not limited to, rehabilitative restitution in money or in
5 kind, curfew, revocation or suspension of the driver's license, community
6 service, deprivation of nonessential activities or privileges, or other
7 appropriate restraints on the inmate's liberty.

8 (d) Upon placement in a house arrest program, the court, secretary or
9 house arrest staff shall inform the offender, and any other people residing
10 with such offender, of the nature and extent of such house arrest
11 monitoring, and shall obtain the written agreement of such offender to
12 comply with all requirements of the program.

13 (e) The offender shall remain within the property boundaries of the
14 offender's residence at all times during the term of house arrest, except as
15 provided under the house arrest agreement with such offender.

16 (f) The offender shall allow any law enforcement officer, community
17 corrections officer, court services officer or duly authorized agent of the
18 department of corrections; to enter such offender's residence at any time to
19 verify the offender's compliance with the conditions of the house release.

20 (g) As a condition of house arrest, the court or secretary may require
21 an offender placed under house arrest to pay any supervision costs
22 associated with the house arrest program. *The secretary shall not require a*
23 *juvenile or a juvenile's parent, guardian or custodian to pay any*
24 *supervision costs associated with a house arrest program.*

25 (h) The offender shall consent to be monitored by:

26 (1) An electronic monitoring device on such offender's person;

27 (2) an electronic monitoring device in such offender's home;

28 (3) a remote blood alcohol monitoring device;

29 (4) a home telephone verification procedure;

30 (5) radio frequency devices; or

31 (6) any combination of monitoring methods as the court, secretary or
32 house arrest staff finds necessary.

33 (i) The secretary or the court may contract for independent
34 monitoring services. Such independent monitoring service shall be able to
35 provide monitoring 24 hours a day, every day of the year, and any other
36 services as determined by the secretary or the court.

37 (j) An offender violating the provisions of K.S.A. 8-1567, and
38 amendments thereto, if placed under house arrest, shall be monitored by an
39 electronic monitoring device, which verifies the offender's location. On a
40 second or subsequent conviction of K.S.A. 8-1567, and amendments
41 thereto, an offender placed under house arrest shall serve the total number
42 of hours of confinement mandated by that section.

43 (k) As used in this section:

1 (1) "House arrest staff" means an independent contractor or
2 government entity, and agents thereof, utilized by the secretary or court to
3 administer the provisions of a house arrest program;

4 (2) "electronic monitoring device" means:

5 (A) An active or passive global positioning system-enabled device
6 capable of recording and transmitting an offender's location at all times or
7 at designated intervals. Such monitoring device may record or transmit
8 sound, visual images or other information regarding such offender's
9 location; via wireless communication; or

10 (B) a radio frequency device capable of monitoring an offender's
11 location; and

12 (3) "remote alcohol monitoring device" means a device capable of
13 monitoring an offender's blood alcohol content via micro fuel cell or deep
14 lung tissue sample. Such monitoring devices shall be of comparable
15 accuracy to roadside breath alcohol testing devices utilized by law
16 enforcement, and shall have wireless or landline telephone transmission
17 capabilities. Such device may be used in conjunction with an alcohol and
18 drug-sensing bracelet to monitor such offender's compliance with the
19 terms of house arrest.

20 Sec. 5. K.S.A. 2022 Supp. 22-4905 is hereby amended to read as
21 follows: 22-4905. Any offender required to register as provided in the
22 Kansas offender registration act shall:

23 (a) Except as otherwise provided in this subsection, register in person
24 with the registering law enforcement agency within three business days of
25 coming into any county or location of jurisdiction in which the offender
26 resides or intends to reside, maintains employment or intends to maintain
27 employment, or attends school or intends to attend school. Any such
28 offender who cannot physically register in person with the registering law
29 enforcement agency for such reasons including, but not limited to,
30 incapacitation or hospitalization, as determined by a person licensed to
31 practice medicine or surgery, or involuntarily committed pursuant to the
32 Kansas sexually violent predator act, shall be subject to verification
33 requirements other than in-person registration, as determined by the
34 registering law enforcement agency having jurisdiction;

35 (b) except as provided further, for any: (1) Sex offender, including a
36 violent offender or drug offender who is also a sex offender, report in
37 person four times each year to the registering law enforcement agency in
38 the county or location of jurisdiction in which the offender resides,
39 maintains employment or is attending a school; and (2) violent offender or
40 drug offender, report in person four times each year to the registering law
41 enforcement agency in the county or location of jurisdiction in which the
42 offender resides, maintains employment or is attending a school, except
43 that, at the discretion of the registering law enforcement agency, one of the

1 four required reports may be conducted by certified letter. When utilized,
2 the certified letter for reporting shall be sent by the registering law
3 enforcement agency to the reported residence of the offender. The offender
4 shall indicate any changes in information as required for reporting in
5 person. The offender shall respond by returning the certified letter to the
6 registering law enforcement agency within 10 business days by certified
7 mail. The offender shall be required to report to the registering law
8 enforcement agency once during the month of the offender's birthday and
9 every third, sixth and ninth month occurring before and after the month of
10 the offender's birthday. The registering law enforcement agency may
11 determine the appropriate times and days for reporting by the offender,
12 consistent with this subsection. Nothing contained in this subsection shall
13 be construed to alleviate any offender from meeting the requirements
14 prescribed in the Kansas offender registration act;

15 (c) provide the information required for registration as provided in
16 K.S.A. 22-4907, and amendments thereto, and verify all information
17 previously provided is accurate;

18 (d) if in the custody of a correctional facility, register with the
19 correctional facility within three business days of initial custody and shall
20 not be required to update such registration until discharged, paroled,
21 furloughed or released on work or school release from a correctional
22 facility. A copy of the registration form and any updated registrations for
23 an offender released on work or school release shall be sent, within three
24 business days, to the registering law enforcement agency where the
25 offender is incarcerated, maintains employment or attends school, and to
26 the Kansas bureau of investigation;

27 (e) if involuntarily committed pursuant to the Kansas sexually violent
28 predator act, register within three business days of arrival in the county
29 where the offender resides during commitment. The offender shall not be
30 required to update such registration until placed in a reintegration facility,
31 on transitional release or on conditional release. Upon placement in a
32 reintegration facility, on transitional release or on conditional release, the
33 offender shall be personally responsible for complying with the provisions
34 of the Kansas offender registration act;

35 (f) notwithstanding subsections (a) and (b), if the offender is
36 transient, report in person to the registering law enforcement agency of
37 such county or location of jurisdiction in which the offender is physically
38 present within three business days of arrival in the county or location of
39 jurisdiction. Such offender shall be required to register in person with the
40 registering law enforcement agency every 30 days, or more often at the
41 discretion of the registering law enforcement agency. Such offender shall
42 comply with the provisions of the Kansas offender registration act and, in
43 addition, shall:

- 1 (1) Provide a list of places where the offender has slept and otherwise
2 frequented during the period of time since the last date of registration; and
3 (2) provide a list of places where the offender may be contacted and
4 where the offender intends to sleep and otherwise frequent during the
5 period of time prior to the next required date of registration;
6 (g) if required by out-of-state law, register in any out-of-state
7 jurisdiction, where the offender resides, maintains employment or attends
8 school;
9 (h) register in person upon any commencement, change or
10 termination of residence location, employment status, school attendance or
11 other information as provided in K.S.A. 22-4907, and amendments thereto,
12 within three business days of such commencement, change or termination,
13 to the registering law enforcement agency or agencies where last
14 registered and provide written notice to the Kansas bureau of
15 investigation;
16 (i) report in person to the registering law enforcement agency or
17 agencies within three business days of any change in name;
18 (j) if receiving inpatient treatment at any treatment facility, inform the
19 treatment facility of the offender's status as an offender and inform the
20 registering law enforcement agency of the county or location of
21 jurisdiction in which the treatment facility is located of the offender's
22 presence at the treatment facility and the expected duration of the
23 treatment;
24 (k) submit to the taking of an updated photograph by the registering
25 law enforcement agency on each occasion when the offender registers with
26 or reports to the registering law enforcement agency in the county or
27 location of jurisdiction in which the offender resides, maintains
28 employment or attends school. In addition, such offender shall submit to
29 the taking of a photograph to document any changes in identifying
30 characteristics, including, but not limited to, scars, marks and tattoos;
31 (l) remit payment to the sheriff's office in the amount of \$20 as part of
32 the reporting process required pursuant to subsection (b) in each county in
33 which the offender resides, maintains employment or is attending school.
34 Registration will be completed regardless of whether or not the offender
35 remits payment. Failure of the offender to remit full payment within 15
36 days of registration is a violation of the Kansas offender registration act
37 and is subject to prosecution pursuant to K.S.A. 22-4903, and amendments
38 thereto. Notwithstanding other provisions ~~herein~~ *of this section*, payment
39 of this fee is not required:
40 (1) When an offender provides updates or changes in information or
41 during an initial registration unless such updates, changes or initial
42 registration is during the month of such offender's birthday and every
43 third, sixth and ninth month occurring before and after the month of the

- 1 offender's birthday;
- 2 (2) when an offender is transient and is required to register every 30
- 3 days, or more frequently as ordered by the registering law enforcement
- 4 agency, except during the month of the offender's birthday and every third,
- 5 sixth and ninth month occurring before and after the month of the
- 6 offender's birthday;~~or~~
- 7 (3) if an offender has, prior to the required reporting and within the
- 8 last three years, been determined to be indigent by a court of law, and the
- 9 basis for that finding is recorded by the court; *or*
- 10 (4) *when an offender is required to register solely because of a*
- 11 *juvenile adjudication;*
- 12 (m) annually renew any driver's license pursuant to K.S.A. 8-247, and
- 13 amendments thereto, and annually renew any identification card pursuant
- 14 to K.S.A. 2022 Supp. 8-1325a, and amendments thereto;
- 15 (n) if maintaining primary residence in this state, surrender all driver's
- 16 licenses and identification cards from other states, territories and the
- 17 District of Columbia, except if the offender is presently serving and
- 18 maintaining active duty in any branch of the United States military or the
- 19 offender is an immediate family member of a person presently serving and
- 20 maintaining active duty in any branch of the United States military;
- 21 (o) read and sign the registration form noting whether the
- 22 requirements provided in this section have been explained to the offender;
- 23 and
- 24 (p) report in person to the registering law enforcement agency in the
- 25 jurisdiction of the offender's residence and provide written notice to the
- 26 Kansas bureau of investigation 21 days prior to any travel outside of the
- 27 United States, and provide an itinerary including, but not limited to,
- 28 destination, means of transport and duration of travel, or if under
- 29 emergency circumstances, within three business days of making travel
- 30 arrangements.

31 Sec. 6. K.S.A. 28-170 is hereby amended to read as follows: 28-170.

32 (a) The docket fee prescribed by K.S.A. 60-2001, and amendments thereto,
33 and the fees for service of process, shall be the only costs assessed for
34 services of the clerk of the district court and the sheriff in any case filed
35 under chapter 60 or chapter 61 of the Kansas Statutes Annotated, and
36 amendments thereto, except that no fee shall be charged for an action filed
37 under K.S.A. 60-3101 et seq., ~~and under~~ *or* K.S.A. 60-31a01 et seq., and
38 amendments thereto. For services in other matters in which no other fee is
39 prescribed by statute, the following fees shall be charged and collected by
40 the clerk. Only one fee shall be charged for each bond, lien or judgment:

- 41 1. For filing, entering and releasing a bond, mechanic's lien, notice of
- 42 intent to perform, personal property tax judgment or any judgment on
- 43 which execution process cannot be issued\$14

1 2. For filing, entering and releasing a judgment of a court of this state on
2 which execution or other process can be issued \$24

3 3. For a certificate, or for copying or certifying any paper or writ, such fee
4 as shall be prescribed by the district court.

5 (b) The fees for entries, certificates and other papers required in
6 naturalization cases shall be those prescribed by the federal government
7 and, when collected, shall be disbursed as prescribed by the federal
8 government. The clerk of the court shall remit to the state treasurer at least
9 monthly all moneys received from fees prescribed by subsection (a) or (b)
10 or received for any services performed which may be required by law. The
11 state treasurer shall deposit the remittance in the state treasury and credit
12 the entire amount to the state general fund.

13 (c) In actions pursuant to the revised Kansas code for care of
14 children, K.S.A. 38-2201 et seq., and amendments thereto, ~~the revised~~
15 ~~Kansas juvenile justice code, K.S.A. 38-2301 et seq., and amendments~~
16 ~~thereto~~, the act for treatment of alcoholism, K.S.A. 65-4001 et seq., and
17 amendments thereto, the act for treatment of drug abuse, K.S.A. 65-5201
18 et seq., and amendments thereto, or the care and treatment act for mentally
19 ill persons, K.S.A. 59-2945 et seq., and amendments thereto, the clerk
20 shall charge an additional fee of \$1 which shall be deducted from the
21 docket fee and credited to the prosecuting attorneys' training fund as
22 provided in K.S.A. 28-170a, and amendments thereto.

23 (d) Except as provided further, the bond, lien or judgment fee
24 established in subsection (a) shall be the only fee collected or moneys in
25 the nature of a fee collected for such bond, lien or judgment. Such fee shall
26 only be established by an act of the legislature and no other authority is
27 established by law or otherwise to collect a fee. On and after July 1, 2019,
28 through June 30, 2025, the supreme court may impose an additional
29 charge, not to exceed \$22 per bond, lien or judgment fee, to fund the costs
30 of non-judicial personnel, *except that such fee shall not be imposed in any*
31 *action pursuant to the revised Kansas juvenile justice code.*

32 Sec. 7. K.S.A. 28-170a is hereby amended to read as follows: 28-
33 170a. (a) There is hereby established a prosecuting attorneys' training
34 fund. The clerk of the district court shall charge a fee of \$1 in each
35 criminal case, to be deducted from the docket fee as provided in K.S.A.
36 28-172a, and amendments thereto and shall charge a fee of \$1 in each case
37 pursuant to the revised Kansas code for care of children ~~or the revised~~
38 ~~Kansas juvenile justice code~~ and each mental illness, drug abuse or
39 alcoholism treatment action as provided by ~~subsection (c)~~ of K.S.A. 28-
40 170(c), and amendments thereto. The clerk of the district court, at least
41 monthly, shall pay all such fees received to the county treasurer who shall
42 credit the same to the prosecuting attorneys' training fund.

43 (b) Expenditures from the prosecuting attorneys' training fund shall

1 be paid by the county treasurer upon the order of the county or district
2 attorney and shall be used exclusively for the training of personnel in such
3 attorney's office and costs related thereto. Annually, on or before March
4 15, each county and district attorney shall submit to the attorney general
5 and the chairperson of the judiciary committee of each house, an
6 accounting that shows for the preceding year the amount of fees paid into
7 the prosecuting attorneys' training fund, the amounts and purpose of each
8 expenditure from such fund and the balance in such fund on December 31
9 of the preceding year. The purpose for each expenditure shall specifically
10 identify the person or persons for whom the expenditure was made and,
11 where applicable, the time and place where the training was received. If
12 any expenditure was paid to a nonprofit organization organized in this
13 state of which the county or district attorney is a member, the county or
14 district attorney shall include information on the training received for such
15 expenditure which information shall show the persons receiving the
16 training and the time and place thereof.

17 Sec. 8. K.S.A. 28-176 is hereby amended to read as follows: 28-176.
18 (a) The court shall order any person convicted or diverted, ~~or adjudicated~~
19 ~~or diverted under a preadjudication program~~ pursuant to K.S.A. 22-2906 et
20 seq., ~~K.S.A. 38-2346 et seq.~~, or 12-4414, and amendments thereto, of a
21 misdemeanor or felony contained in chapters 21, 41 or 65 of the Kansas
22 Statutes Annotated, and amendments thereto, or a violation of K.S.A. 8-
23 2,144 or 8-1567, and amendments thereto, or a violation of a municipal
24 ordinance or county resolution prohibiting the acts prohibited by such
25 statutes, unless the municipality or county has an agreement with the
26 laboratory providing services that sets a restitution amount to be paid by
27 the person that is directly related to the cost of laboratory services, to pay a
28 separate court cost of \$400 for every individual offense if forensic science
29 or laboratory services, forensic computer examination services or forensic
30 audio and video examination services are provided, in connection with the
31 investigation, by:

32 (1) The Kansas bureau of investigation;
33 (2) the Sedgwick county regional forensic science center;
34 (3) the Johnson county sheriff's laboratory;
35 (4) the heart of America regional computer forensics laboratory;
36 (5) the Wichita-Sedgwick county computer forensics crimes unit; or
37 (6) the Garden City police department computer, audio and video
38 forensics laboratory.

39 (b) Such fees shall be in addition to and not in substitution for any
40 and all fines and penalties otherwise provided for by law for such offense.

41 (c) The court shall not lessen or waive such fees unless the court has
42 determined such person is indigent and the basis for the court's
43 determination is reflected in the court's order.

1 (d) Such fees shall be deposited into the designated fund of the
2 laboratory or forensic science or computer center that provided such
3 services. Fees for services provided by:

4 (1) The Kansas bureau of investigation shall be deposited in the
5 Kansas bureau of investigation forensic laboratory and materials fee fund
6 which is hereby created;

7 more than five days, excluding Saturdays, Sundays and legal holidays,

9 facility, the continuing detention, custody, and control of and transport for

11 correctional facility shall be the responsibility of the committing county.

13 the secretary may make any temporary out-of-home placement the
14 secretary deems appropriate pending placement of the juvenile offender in
15 a juvenile correctional facility, and the secretary shall notify the court,

17 be residing if the juvenile is still required to attend a secondary school of
18 that placement.

19 (c) *Transfers.* During the time a juvenile offender remains committed
20 to a juvenile correctional facility, the secretary may transfer the juvenile

34 custody and shall clearly define the role of each person or agency working
35 with the juvenile. The case plan shall include a reentry section, detailing
36 services, education, supervision or any other elements necessary for a
37 successful transition. The reentry section of the case plan shall also include
38 information on reintegration of the juvenile into such juvenile's family or,
39 if reintegration is not a viable alternative, another viable release option. If
40 the juvenile is to be placed on conditional release pursuant to K.S.A. 38-
41 2369, the case plan shall be developed with the community supervision
42 officer.
