#### 2017 Session Deadlines

The following dates are the deadlines for introduction and consideration of bills for the 2017 session. These dates were adopted as part of the Joint Rules of the Senate and House of Representatives.

#### Monday, January 30th

Last day for <u>member</u> or <u>members</u> to REQUEST bill drafts from Revisor's office.

#### Monday, February 6th

Last day for <u>non-exempt Committees</u> to REQUEST bill drafts from the Revisor's office.

Note: This is the last day requests for introduction can be on non-exempt committee agendas.

### Wednesday, February 8th

Last day for <u>Individuals</u> to INTRODUCE bills in originating chamber. Note: Bills must be submitted to chamber staff during daily session for Introduction.

### Friday, February 10th

Last day for <u>non-exempt Committees</u> to INTRODUCE bills in originating chamber. Note: Bills must be submitted to chamber staff during daily session for Introduction.

## Thursday, February 23rd (Turnaround Day)

Last day to consider non-exempt bills in house of origin.

#### Thursday, March 30<sup>th</sup>

Last day to consider non-exempt bills not in originating chamber.

### Friday, April 7th (Drop Dead Day)

No bills considered after this date except bills vetoed by governor, omnibus appropriations act and omnibus reconciliations spending limit bill.

**Veto session** is anticipated to begin on Monday, May 1<sup>st</sup>.

**Exempt committees:** House and Senate Federal and State Affairs, Senate Ways and Means, Senate Assessment and Taxation, House committees on Calendar and Printing, Appropriations, Taxation or select committees of either house when so authorized.

**Exempt bills** are those sponsored by, referred to or acted upon by an exempt committee.
