Re: Testimony on House Bill 2503 - Agriculture Boards and Advisory Bodies

Chairman Taddiken and members of the Committee, thank you for allowing me the opportunity to comment in support of HB 2503. I am Randy Stookey, General Counsel for the Kansas Grain and Feed Association and the Kansas Agribusiness Retailers Association. I also serve as administrator of the five-member Kansas Agricultural Remediation Board, or KARB, which manages the agricultural remediation fund program.

The remediation fund program is entirely funded by fees paid by members of our associations, including: grain storage facilities, custom fertilizer blenders, pesticide and fertilizer retailers, and pesticide business licensees. The KARB Board distributes the funds to companies that have contributed to the fund and have incurred expenses from actions to remediate a contaminated site upon the order or approval of KDHE.

Currently, KARB board members are appointed by the Governor and are confirmed by the Senate following a KBI background check. Board member comments indicate that this background check is unnecessarily burdensome, and that interviews with family members and friends are personally invasive. Section 1 of HB 2503 seeks to amend KSA 2-3709 to allow KARB nominees to be seated upon Governor appointment alone. The intent of the amendment is to encourage qualified candidates to apply for the KARB through a simpler, quicker process that is a less expensive and time consuming for both the nominee and the State.

Senate confirmation is generally reserved for heads of state agencies and board governing agencies, most of whom handle state general fund appropriations. KARB receives no SGF, however, other than a small stipend for board meeting travel. The Board merely distributes industry funds, quarterly, back to the industry from which they were collected - similar to state grain commissions. In addition, the fund is subject to an annual independent audit, and the Board submits the audit and a program report each January to the Governor, the House Committee on Agriculture, and this committee.

The House Committee of the Whole favorably passed 2503 with a vote of 124 to 0. While the KBI background check often serves a legitimate purpose, it would be more appropriate to treat the KARB board like the vast number of State entities that do not require Senate confirmation. We, therefore, stand in support of HB 2503 and encourage the committee to act favorably on the bill.
