MR. CHAIRMAN & COMMITTEE: I APPRECIATE YOU ALLOWING ME TO COME AND SPEAK TO YOU TODAY ABOUT SB 376. I HAVE BEEN VOTED IN AS PRESIDENT OF SELF-SERVE LAUNDRY OWNERS ACROSS KANSAS AND MISSOURI. I HAVE BEEN PRESIDENT FOR OVER 10 YEARS AND HAVE OWNED A LAUNDRY MYSELF FOR OVER 20 YEARS.

CONCERNING SB 376 AND THE REMOVING OF THE EXEMPTION FROM SELF-SERVE LAUNDRIES I AM SPEAKING TODAY AND ASKING THAT YOU LEAVE THE EXEMPTION ON THE BOOKS.

SELF-SERVE LAUNDRIES IS OF A BASIC HEALTH CONCERN TO EVERY INDIVIDUAL IN THE STATE OF KANSAS. THE NATIONAL COIN LAUNDRY ASSN. STATISTICS SHOW THAT ABOUT 40% OF ALL AMERICANS USE LAUNDRY FACILITIES. OUR SOCIETY TODAY SHUNS THOSE THAT COME ACROSS OUR PATHS THAT ARE EITHER UNCLEAN OR HAVE FILTHY CLOTHING. BACTERIA BREEDS IN DIRTY CLOTHING. HOW MUCH IS IT A PROBLEM IN THE PUBLIC SCHOOLS SYSTEM DEALING WITH LICE EVERY YEAR. AND ON TOP OF THAT WE NOW HAVE BED BUGS TO DEAL WITH THAT PLAGUE MANY KANSANS.

OF WHICH THIS MEANS WE ARE A RE-SELLER OF UTILITIES OF WHICH WE RAISE THOUSANDS & THOUSANDS OF DOLLARS FOR THE STATE EVERY YEAR NOW IN THE TAXES WE PAY ON THOSE UTILITIES. SO REMOVING THE EXEMPTION WOULD BE THAT WE WOULD BE DOUBLED TAXED WHICH WOULD MAKE IT AN UNFAIR TAX TO EVERY LAUNDRY OWNER IN KANSAS. MANY OF WHICH DO NOT THINK THAT THEY CAN RAISE THEIR PRICES ANY MORE NOW
