Bill Introductions:

Pat George, Acting Secretary, Kansas Department of Commerce, requested introduction of conceptual bill relating to business expensing including the roll-back of certain tax credits. Representative Carlson moved to introduce such bill, Representative Schwartz seconded the motion. The motion carried.

Pat George, Acting Secretary, Kansas Department of Commerce requested introduction of a bill relating to the rural opportunity zones providing for income tax relief and student loan forgiveness. Representative Carlson moved introduction of the bill. The motion was seconded by Representative Kleeb. The motion carried.

Acting Secretary of Commerce Pat George provided a brief overview of his background and offered insight into the initiatives of the Kansas Department of Commerce. The Department looks to grow the Kansas economy and provide an environment that creates more jobs in the state, which is fundamentally the job of the Department.
