# HB 2436 - Concerning Public Utilities and Issuance of Certificate of Public Convenience

Tamera Lawrence, Assistant Revisor of Statutes, explained the purpose of **HB 2436** was to put a time limit on KCC to make a decision on an application for a certificate of public convenience within 180 days of receiving such application. (<u>Attachment 1</u>)

### Chair opened the hearing on:

### HB 2526 - Oil & Gas; regulation of hydraulic fracturing

Tamera Lawrence, Assistant Revisor of Statutes, explained the purpose of **HB 2526** is to provide authority to the KCC to promulgate rules and regulations necessary for the supervision and disclosure of any well on which a hydraulic fracturing treatment is performed. (<u>Attachment 3</u>)

#### **Proponents**

Ed Cross, President, Kansas Independent Oil & Gas Association, KIOGA believes it is important to maintain the current state regulatory process and the KCC is the best place to address any hydraulic fracturing concerns. He also provided a paper on The Whole Fracking Story. (Attachment 4)

Tom Day, Kansas Corporation Commission (KCC), supports HB 2526. (Attachment 5)

Zack Pistora, Kansas Sierra Club, spoke in favor of **HB 2526** as it allows for more explicit oversight over hydraulic fracturing sites. (<u>Attachment 6</u>)
