1	AN ACT concerning school districts; relating to the assessed valuation of
2	certain school districts.
3	
4	Be it enacted by the Legislature of the State of Kansas:
5	Section 1. (a) For the purpose of computing the assessed
6	valuation of school districts for the payment, distribution or allocation of
7	state aid and the levying of school taxes, the assessed valuation of the
8	property shall be assigned to each of the school districts as follows:
9	(1) Determine the assessed valuation of each school district on
10	July 1, excluding that portion of the assessed valuation of the property
11 12	that would otherwise be included in the assessed valuation of the school
12	district; (2) determine the proportional assessed valuation of each
13 14	(2) determine the proportional assessed valuation of each school district by dividing the amount determined under paragraph (1) by
15	the aggregate of all amounts determined under paragraph (1); and
16	(3) multiply the proportional assessed valuation of each school
17	district by the assessed valuation of the property. The resulting product is
18	the assessed valuation assigned to the school district. The determinations
19	made pursuant to this section shall be done by the county clerk of Labette
20	county. The assessed valuation assigned to each school district shall be
21	reported by the county clerk to each school district and to the state board
22	of education.
23	(b) As used in this section:
24	(1) "Property" means the following described real estate and
25	improvements thereon, which is located in Labette county:
26	(A) All of the former Kansas army ammunitions plant property
27	being a parcel of land located in sections 22, 23, 25, 26, 27, 33, 34, 35
28	and 36 of township 31 south, range 20 east and sections 28, 31, 32 and 33
29	of township 31 south, range 21 east and sections 1, 2, 3, 4, 9, 10, 11, 12,
30	13, 14, 15, 16, 22, 23 and 24 of township 32 south, range 20 east and

 principal meridian, county of Labette, state of Kansas more particularly

22	thence north 51° 16' 34" east a distance of 131.16 feet to the west line of

the aforementioned section 23, township 32 south, range 20 east; thence north 00° 07' 33" east, along the said west line, a distance of 571.67 feet to the point of beginning. The above described property is intended to encompass all that land known as the former Kansas army ammunition plant owned by the United States of America, containing an area of 13,946.10 acres of land, more or less.

7 (B) That part of lot 3 in the southeast quarter of section 28,
8 township 31 south, range 21 east of the 6th p.m., bounded and described
9 as follows:

10 Beginning at a point on the south line of said southeast quarter of section 11 28, said point being 536.35 feet east of the southwest corner of the 12 southeast guarter of said section 28; thence northerly at right angles to 13 said south line of southeast guarter of section 28 a distance of 200.0 feet; 14 thence, easterly at right angles to last described line, a distance of 277.0 15 feet, more or less to the west line of the Neosho river thence southerly 16 along the west line of the Neosho river to the south line of said southeast 17 quarter of section 28, a distance of 280.0 feet, more or less to the point of 18 beginning.

That part of lot 6 in the northeast quarter of section 33, township 31
south, range 21 east of the 6th p.m., bounded and described as follows:
Beginning at a point on the north line of said northeast quarter of section

northeast quarter of said section 33, thence southerly at right angles to 1 2 said north line of northeast guarter of section 33 a distance of 400.0 feet; 3 thence easterly at right angles to last described line, a distance of 317.0 4 feet, more or less to the west line of the Neosho river; thence northerly 5 along the west line of the Neosho river to the north line of said northeast 6 quarter of section 33; thence westerly along the north line of said 7 northeast guarter of section 33, a distance of 280.0 feet more or less to the 8 point of beginning. 9 That part of lot 7 in the northeast guarter of section 33, township 31 10 south, range 21 east of the 6th p.m., bounded and described as follows: 11 Beginning at a point on the north line of said northeast quarter of section 12 33, said point being 1095.83 feet east of the northwest corner of northeast 13 quarter of said section 33, thence southerly at right angles to said north 14 line of northeast guarter of section 33, a distance of 400.0 feet; thence westerly at right angles to last described line, a distance of 89 feet more 15 16 or less to the east line of the Neosho river; thence northerly along the east 17 line of the Neosho river to said north line of the northeast quarter of 18 section 33; thence easterly along said north line of northeast quarter of 19 section 33, a distance of 150.0 feet more or less to the point of beginning. (2) "School district" means unified school district No. 503. 20 21 unified school district No. 504, unified school district No. 505 and 22 unified school district No. 506.

1 (3) "State aid" means general state aid, supplemental general 2 state aid, capital improvements state aid, capital outlay state aid and any 3 other state aid paid, distributed or allocated to school districts under the 4 school district finance and quality performance act or other law, and any 5 other state aid paid, distributed or allocated to school districts on the basis 6 of the assessed valuation of school districts.

7 Sec. 2. This act shall take effect and be in force from and after its8 publication in the statute book.
