| 4 | Be it enacted by the Legislature of the State of Kansas: |
| 5 | Section 1. (a) Home improvement fraud is: |
| 6 | (1) Receiving money for the purpose of obtaining or paying for- |
| 7 | services, labor, materials or equipment and failing to apply such money for |
| 8 | such purpose as evidenced by failing to substantially complete the home |
| 9 | improvement for which such funds were provided; or |

| 12 | false promise; |

| 15 | (C)(3) knowingly making a false statement of material fact or |
| 16 | omitting a material fact relating to the home improvement contract; or |
| 17 | (D)(4) damaging property of the owner with the intent to induce such |

4 (3) (A) "home improvement" means any repair, replacement, 5 remodeling, installation, conversion, modernization, improvement made 6 to, in or upon, any immovable or moveable property or to any land or 7 building or that portion thereof which is used or designed to be used as a 8 private residence or residential rental property, including, but not limited 9 to:

- 10 (i) Waterproofing;
- 11 (ii) exterior siding, awnings, gutters and downspouts;
- 12 (iii) decks, patios, sunrooms, garages, carports and additional rooms;
- 13 (iv) storm or replacement windows and doors;
- 14 (v) roofs;
- 15 (vi) driveways and walkways;
- 16 (vii) kitchens and bathrooms;
- 17 (viii) masonry;
- 18 (ix) fence installations;
- 19 (x) chimney maintenance;
- 20 (xi) exterior painting;
- 21 (xii) landscaping, gardening and arboriculture;
- 22 (xiii) tile setting;
- 23 (xiv) sandblasting;
- 24 (xv) swimming pools; and
- 25 (xvi) other similar improvements; and

(B) "home improvement" does not include construction of a new
home, the sale of goods or services furnished for commercial or business
use or resale, or any work performed without compensation by the owner
on such owner's private residence or residential rental property;

(4) "home improvement contract" means an oral or written agreement
between a contractor and an owner for the performance of home
improvement by the contractor or another in exchange for money, whether
or not such money is paid;

(5) "material fact" means a fact that a reasonable person would
consider important when purchasing a home improvement of the variety
being offered;

(6) "owner" means a person who owns or resides in a privateresidence or residential rental property;

(7) "private residence or home" means a single-family or multi-family dwelling consisting of not more than four attached units; and

(8) "residential rental property" means a single-family or multi-family
dwelling consisting of not more than four attached units that is not owneroccupied:{.} and

- 1 (9) "substantially complete" means the owner realizes a material-2 benefit from the home improvement contract.
- 3 (d) This section shall be part of and supplemental to the Kansas 4 criminal code.
- 5 Sec. 2. This act shall take effect and be in force from and after its 6 publication in the statute book.
