1 AN ACT concerning the boards of ~~cosmetology and barbering~~ **barbering**
2 **and cosmetology**; inspection of dual licensed facilities; ~~amending~~
3 K.S.A. 65-1907 and repealing the existing section.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. ~~K.S.A. 65-1907 is hereby amended to read as follows: 65-~~
7 ~~1907. Except as otherwise provided, the chairperson, with the approval of~~
8 ~~the board, shall employ inspectors to inspect schools, salons and clinics~~
9 ~~and the inspectors shall perform all of the inspection duties of the board, as~~
10 ~~required by this act, rules and regulations of the board and sanitation~~
11 ~~standards adopted by the secretary of health and environment pursuant to~~
12 ~~K.S.A. 65-1,148 and amendments thereto. The chairperson, with the~~
13 ~~approval of the board, may designate the Kansas board of barbering-~~
14 ~~inspectors to perform routine inspections of dual-licensed salons and~~
15 ~~barber shops and the inspectors shall perform all of the inspection duties~~
16 ~~of the board, as required by this act, rules and regulations of the board~~
17 ~~and sanitation standards adopted by the secretary of health and~~
18 ~~environment pursuant to K.S.A. 65-1,148, and amendments thereto. The~~
19 ~~board shall provide training to the inspectors to enable the inspectors to~~
20 ~~provide current information to school, salon and clinic personnel regarding~~
21 ~~requirements of applicable statutes and regulations. It shall be the duty of~~
22 ~~the board to determine the number of hours and practice work required of~~
23 ~~students in each subject of cosmetology, nail technology, esthetics and~~
24 ~~electrology taught in a licensed school.~~

25 Sec. 2. ~~K.S.A. 65-1907 is hereby repealed.~~

26 Section 1. **The chairpersons of the board of barbering and the**
27 **board of cosmetology may come to an agreement, approved by each**
28 **board, as to which board's inspectors shall inspect a dual-licensed**
29 **salon and barber shop. Such designated inspectors shall perform all of**
30 **the inspection duties of both boards as required by the act, rules and**
31 **regulations of both boards and the sanitation standards adopted by**
32 **the secretary of health and environment pursuant to K.S.A. 65-1,148,**
33 **and amendments thereto. Such designated inspectors shall be trained**
34 **by both boards.**
