9 *Be it enacted by the Legislature of the State of Kansas:*

10 *{Section 1. K.S.A. 2013 Supp. 75-5673 is hereby amended to read as*
11 *follows: 75-5673. (a) The secretary of health and environment shall*
12 *establish a statewide atmospheric mercury deposition monitoring*
13 *network to measure mercury deposition in Kansas. The network shall*
14 *consist of no fewer than six sites in Kansas. At least two such sites shall be*
15 *located to measure mercury deposition entering the state from the direction*
16 *of prevailing winds. Mercury deposition samples shall be collected at each*
17 *site on a weekly basis and concentration, precipitation and other pertinent*
18 *values shall be recorded.*

19 *(b) The secretary of health and environment shall contract with a*
20 *laboratory that has demonstrated capability to perform appropriate*
21 *analysis of the samples collected and to provide reports in a form*
22 *acceptable to the secretary. After analysis, data and analysis reports,*
23 *including data on long term trends, shall be provided to the public*
24 *through a website. Data also will be posted to a national database*
25 *designated by the secretary.*

26 *(c) The secretary of health and environment shall ensure that data*
27 *collected from the network and analyses of those data are made*
28 *available specifically to Kansas-based research institutes and scientists*
29 *for exploration of the impact of mercury on Kansas flora, fauna and*
30 *human population.*

31 ~~*(d) On or before the first day of the regular legislative session in 2009*~~
32 ~~*and each year thereafter, the secretary of health and environment shall*~~

1 ~~prepare and submit to the governor and the chairperson, vice-chairperson~~
