1 AN ACT concerning crimes, punishment and criminal procedure; relating
2 to capital murder; attempt; sentencing; amending *K.S.A. 22-3405, 22-*
3 *3705 and 22-4210 and* K.S.A. 2013 Supp. 21-5301, 21-5401, **21-5414**
4 ~~and 21-6620, 21-6617, 21-6620, 21-6626, 22-3717 and 22-3728~~ and
5 repealing the existing sections.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 2013 Supp. 21-5301 is hereby amended to read as
9 follows: 21-5301.(a) An attempt is any overt act toward the perpetration of
10 a crime done by a person who intends to commit such crime but fails in the
11 perpetration thereof or is prevented or intercepted in executing such crime.

12 (b) It shall not be a defense to a charge of attempt that the
13 circumstances under which the act was performed or the means employed
14 or the act itself were such that the commission of the crime was not
15 possible.

16 (c) (1) An attempt to commit an off-grid felony shall be ranked at
17 nondrug severity level 1. An attempt to commit any other nondrug felony
18 shall be ranked on the nondrug scale at two severity levels below the
19 appropriate level for the underlying or completed crime. The lowest
20 severity level for an attempt to commit a nondrug felony shall be a severity
21 level 10.

22 (2) The provisions of this subsection shall not apply to a violation of
23 attempting to commit the crime of:

24 (A) Aggravated human trafficking, as defined in subsection (b) of
25 K.S.A. 2013 Supp. 21-5426, and amendments thereto, if the offender is 18
26 years of age or older and the victim is less than 14 years of age;

27 (B) terrorism, as defined in K.S.A. 2013 Supp. 21-5421, and
28 amendments thereto;

29 (C) illegal use of weapons of mass destruction, as defined in K.S.A.
30 2013 Supp. 21-5422, and amendments thereto;

31 (D) rape, as defined in subsection (a)(3) of K.S.A. 2013 Supp. 21-
32 5503, and amendments thereto, if the offender is 18 years of age or older;

33 (E) aggravated indecent liberties with a child, as defined in
34 subsection (b)(3) of K.S.A. 2013 Supp. 21-5506, and amendments thereto,

1 if the offender is 18 years of age or older;

2 (F) aggravated criminal sodomy, as defined in subsection (b)(1) or (b)
3 (2) of K.S.A. 2013 Supp. 21-5504, and amendments thereto, if the
4 offender is 18 years of age or older;

5 (G) commercial sexual exploitation of a child, as defined in K.S.A.
6 2013 Supp. 21-6422, and amendments thereto, if the offender is 18 years
7 of age or older and the victim is less than 14 years of age; or

8 (H) sexual exploitation of a child, as defined in subsection (a)(1) or
9 (a)(4) of K.S.A. 2013 Supp. 21-5510, and amendments thereto, if the
10 offender is 18 years of age or older and the child is less than 14 years of
11 age; or

12 (I) *capital murder, as defined in K.S.A. 2013 Supp. 21-5401, and*
13 *amendments thereto.*

14 (d) (1) An attempt to commit a felony which prescribes a sentence on
15 the drug grid shall reduce the prison term prescribed in the drug grid block
16 for an underlying or completed crime by six months.

17 (2) The provisions of this subsection shall not apply to a violation of
18 attempting to commit a violation of K.S.A. 2013 Supp. 21-5703, and
19 amendments thereto.

20 (e) An attempt to commit a class A person misdemeanor is a class B
21 person misdemeanor. An attempt to commit a class A nonperson
22 misdemeanor is a class B nonperson misdemeanor.

23 (f) An attempt to commit a class B or C misdemeanor is a class C
24 misdemeanor.

25 Sec. 2. K.S.A. 2013 Supp. 21-5401 is hereby amended to read as
26 follows: 21-5401. (a) Capital murder is the:

27 (1) Intentional and premeditated killing of any person in the
28 commission of kidnapping, as defined in subsection (a) of K.S.A. 2013
29 Supp. 21-5408, and amendments thereto, or aggravated kidnapping, as
30 defined in subsection (b) of K.S.A. 2013 Supp. 21-5408, and amendments
31 thereto, when the kidnapping or aggravated kidnapping was committed
32 with the intent to hold such person for ransom;

33 (2) intentional and premeditated killing of any person pursuant to a
34 contract or agreement to kill such person or being a party to the contract or
35 agreement pursuant to which such person is killed;

36 (3) intentional and premeditated killing of any person by an inmate or
37 prisoner confined in a state correctional institution, community
38 correctional institution or jail or while in the custody of an officer or
39 employee of a state correctional institution, community correctional
40 institution or jail;

41 (4) intentional and premeditated killing of the victim of one of the
42 following crimes in the commission of, or subsequent to, such crime:
43 Rape, as defined in K.S.A. 2013 Supp. 21-5503, and amendments thereto,

1 criminal sodomy, as defined in subsections (a)(3) or (a)(4) of K.S.A. 2013
2 Supp. 21-5504, and amendments thereto, or aggravated criminal sodomy,
3 as defined in subsection (b) of K.S.A. 2013 Supp. 21-5504, and
4 amendments thereto, or any attempt thereof, as defined in K.S.A. 2013
5 Supp. 21-5301, and amendments thereto;

6 (5) intentional and premeditated killing of a law enforcement officer;

7 (6) intentional and premeditated killing of more than one person as a
8 part of the same act or transaction or in two or more acts or transactions
9 connected together or constituting parts of a common scheme or course of
10 conduct; or

11 (7) intentional and premeditated killing of a child under the age of 14
12 in the commission of kidnapping, as defined in subsection (a) of K.S.A.
13 2013 Supp. 21-5408, and amendments thereto, or aggravated kidnapping,
14 as defined in subsection (b) of K.S.A. 2013 Supp. 21-5408, and
15 amendments thereto, when the kidnapping or aggravated kidnapping was
16 committed with intent to commit a sex offense upon or with the child or
17 with intent that the child commit or submit to a sex offense.

18 (b) For purposes of this section, "sex offense" means rape, as defined
19 in K.S.A. 2013 Supp. 21-5503, and amendments thereto, aggravated
20 indecent liberties with a child, as defined in subsection (b) of K.S.A. 2013
21 Supp. 21-5506, and amendments thereto, aggravated criminal sodomy, as
22 defined in subsection (b) of K.S.A. 2013 Supp. 21-5504, and amendments
23 thereto, selling sexual relations, as defined in K.S.A. 2013 Supp. 21-6419,
24 and amendments thereto, promoting the sale of sexual relations, as defined
25 in K.S.A. 2013 Supp. 21-6420, and amendments thereto, commercial
26 sexual exploitation of a child, as defined in K.S.A. 2013 Supp. 21-6422,
27 and amendments thereto, or sexual exploitation of a child, as defined in
28 K.S.A. 2013 Supp. 21-5510, and amendments thereto.

29 (c) Capital murder *or attempt to commit capital murder* is an off-grid
30 person felony.

31 (d) *The provisions of subsection (c) of K.S.A. 2013 Supp. 21-5301,*
32 *and amendments thereto, shall not apply to a violation of attempting to*
33 *commit the crime of capital murder pursuant to this section.*

34 **Sec. 3. K.S.A. 2013 Supp. 21-5414 is hereby amended to read as**
35 **follows: 21-5414. (a) Domestic battery is:**

36 (1) **Knowingly or recklessly causing bodily harm by a family or**
37 **household member against a family or household member; or**

38 (2) **knowingly causing physical contact with a family or**
39 **household member by a family or household member when done in a**
40 **rude, insulting or angry manner.**

41 (b) **Domestic battery is:**

42 (1) **Except as provided in subsection (b)(2) or (b)(3), a class B**
43 **person misdemeanor and the offender shall be sentenced to not less**

1 **than 48 consecutive hours nor more than six months' imprisonment**
2 **and fined not less than \$200; nor more than \$500** ~~or in the court's~~
3 ~~discretion the court may enter an order which requires. As a condition of~~
4 *any grant of probation, suspension of sentence or parole or of any other*
5 *release, the offender shall be required to undergo a domestic violence*
6 **offender assessment conducted by a certified batterer intervention**
7 **program and follow all recommendations made by such program,**
8 *unless otherwise ordered by the court;*

9 (2) **except as provided in subsection (b)(3), a class A person**
10 **misdemeanor, if, within five years immediately preceding commission**
11 **of the crime, an offender is convicted of domestic battery a second**

27 (3) **a person felony, if, within five years immediately preceding**
28 **commission of the crime, an offender is convicted of domestic battery**
29 **a third or subsequent time, and the offender shall be sentenced to not**
30 **less than 90 days nor more than one year's imprisonment and fined**
31 **not less than \$1,000 nor more than \$7,500. The offender convicted**
32 **shall not be eligible for release on probation, suspension or reduction**
33 **of sentence or parole until the offender has served at least 90 days**
34 **imprisonment. As a condition of any grant of probation, suspension of**
35 **sentence or parole or of any other release, the offender shall be**
36 **required to undergo a domestic violence offender assessment**
37 **conducted by a certified batterer intervention program and follow all**
38 **recommendations made by such program, unless otherwise ordered by**
39 **the court or department of corrections. If the offender does not undergo**
40 **a domestic violence offender assessment conducted by a certified**
41 **batterer intervention program and follow all recommendations made**
42 **by such program, the offender shall serve not less than 180 days nor**
43 **more than one year's imprisonment. The 90 days imprisonment**

1 **mandated by this paragraph may be served in a work release program**
2 **only after such offender has served 48 consecutive hours**
3 **imprisonment, provided such work release program requires such**
4 **offender to return to confinement at the end of each day in the work**
5 **release program.**

6 (c) *In determining the sentence to be imposed within the limits*
7 *provided for a first, second, third or subsequent offense under this section,*
8 *a court shall consider any available information regarding a current or*
9 *prior protective order issued against such person.*

10 (d) **As used in this section:**

11 (1) **"Family or household member" means persons 18 years of**
12 **age or older who are spouses, former spouses, parents or stepparents**
13 **and children or stepchildren, and persons who are presently residing**
14 **together or who have resided together in the past, and persons who**
15 **have a child in common regardless of whether they have been married**
16 **or who have lived together at any time. "Family or household**
17 **member" also includes a man and woman if the woman is pregnant**
18 **and the man is alleged to be the father, regardless of whether they**
19 **have been married or have lived together at any time; and**

20 (2) *"protective order" means:*

21 (A) *A protection from abuse order issued pursuant to K.S.A. 60-3105,*
22 *60-3106 or 60-3107, and amendments thereto;*

23 (B) *a protective order issued by a court or tribunal of any state or*
24 *Indian tribe that is consistent with the provisions of 18 U.S.C. § 2265, and*
25 *amendments thereto;*

26 (C) *an order issued in this or any other state as a condition of*
27 *probation, suspended sentence, postrelease supervision or at any other*
28 *time during the criminal case or upon appeal that orders the person to*
29 *refrain from having any direct or indirect contact with a family or*
30 *household member; or*

31 (D) *a protection from stalking order issued pursuant to K.S.A. 60-*
32 *31a05 or 60-31a06, and amendments thereto.*

33 (2) (3) **for the purpose of determining whether a conviction is a**
34 **first, second, third or subsequent conviction in sentencing under this**
35 **section:**

36 (A) **"Conviction" includes being convicted of a violation of K.S.A.**
37 **21-3412a, prior to its repeal, this section or entering into a diversion or**
38 **deferred judgment agreement in lieu of further criminal proceedings**
39 **on a complaint alleging a violation of this section;**

40 (B) **"conviction" includes being convicted of a violation of a law**
41 **of another state, or an ordinance of any city, or resolution of any**
42 **county, which prohibits the acts that this section prohibits or entering**
43 **into a diversion or deferred judgment agreement in lieu of further**

1 criminal proceedings in a case alleging a violation of such law,
2 ordinance or resolution;

3 (C) only convictions occurring in the immediately preceding five
4 years including prior to July 1, 2001, shall be taken into account, but
5 the court may consider other prior convictions in determining the
6 sentence to be imposed within the limits provided for a first, second,
7 third or subsequent offender, whichever is applicable; and

8 (D) it is irrelevant whether an offense occurred before or after
9 conviction for a previous offense.

10 ~~(d)~~ (e) A person may enter into a diversion agreement in lieu of
11 further criminal proceedings for a violation of this section or an
12 ordinance of any city or resolution of any county which prohibits the
13 acts that this section prohibits only twice during any five-year period.

14 ~~Sec. 4.~~ *K.S.A. 2013 Supp. 21-6617 is hereby amended to read as*
15 *follows: 21-6617. (a) If a defendant is charged with capital murder, the*
16 *county or district attorney shall file written notice if such attorney*
17 *intends, upon conviction of the defendant, to request a separate*
18 *sentencing proceeding to determine whether the defendant should be*
19 *sentenced to death. In cases where the county or district attorney or a*
20 *court determines that a conflict exists, such notice may be filed by the*
21 *attorney general. Such notice shall be filed with the court and served on*
22 *the defendant or the defendant's attorney not later than seven days after*
23 *the time of arraignment. If such notice is not filed and served as*
24 *required by this subsection, the prosecuting attorney may not request*
25 *such a sentencing proceeding and the defendant, if convicted of capital*
26 *murder, shall be sentenced to life without the possibility of parole, and*
27 *no sentence of death shall be imposed hereunder.*

28 *(b) Except as provided in K.S.A. 2013 Supp. 21-6618 and 21-6622,*

34 *If any person who served on the trial jury is unable to serve on the jury*
35 *for the sentencing proceeding, the court shall substitute an alternate*
36 *juror who has been impaneled for the trial jury. If there are insufficient*
37 *alternate jurors to replace trial jurors who are unable to serve at the*
38 *sentencing proceeding, the trial judge may summon a special jury of 12*
39 *persons which shall determine the question of whether a sentence of*
40 *death shall be imposed. Jury selection procedures, qualifications of*
41 *jurors and grounds for exemption or challenge of prospective jurors in*
42 *criminal trials shall be applicable to the selection of such special jury.*
43 *The jury at the sentencing proceeding may be waived in the manner*

1 *provided by K.S.A. 22-3403, and amendments thereto, for waiver of a*
2 *trial jury. If the jury at the sentencing proceeding has been waived or the*
3 *trial jury has been waived, the sentencing proceeding shall be conducted*
4 *by the court.*

5 *(c) In the sentencing proceeding, evidence may be presented*
6 *concerning any matter that the court deems relevant to the question of*
7 *sentence and shall include matters relating to any of the aggravating*
8 *circumstances enumerated in K.S.A. 2013 Supp. 21-6624, and*
9 *amendments thereto, and any mitigating circumstances. Any such*
10 *evidence which the court deems to have probative value may be received*
11 *regardless of its admissibility under the rules of evidence, provided that*
12 *the defendant is accorded a fair opportunity to rebut any hearsay*
13 *statements. Only such evidence of aggravating circumstances as the*
14 *state has made known to the defendant prior to the sentencing*
15 *proceeding shall be admissible, and no evidence secured in violation of*
16 *the constitution of the United States or of the state of Kansas shall be*
17 *admissible. No testimony by the defendant at the sentencing proceeding*
18 *shall be admissible against the defendant at any subsequent criminal*
19 *proceeding. At the conclusion of the evidentiary presentation, the court*
20 *shall allow the parties a reasonable period of time in which to present*
21 *oral argument.*

22 *(d) At the conclusion of the evidentiary portion of the sentencing*
23 *proceeding, the court shall provide oral and written instructions to the*
24 *jury to guide its deliberations.*

25 *(e) If, by unanimous vote, the jury finds beyond a reasonable doubt*
26 *that one or more of the aggravating circumstances enumerated in K.S.A.*
27 *2013 Supp. 21-6624, and amendments thereto, exist and, further, that*
28 *the existence of such aggravating circumstances is not outweighed by*
29 *any mitigating circumstances which are found to exist, the defendant*
30 *shall be sentenced to death; otherwise, the defendant shall be sentenced*
31 *to life without the possibility of parole. The jury, if its verdict is a*
32 *unanimous recommendation of a sentence of death, shall designate in*
33 *writing, signed by the foreman of the jury, the statutory aggravating*
34 *circumstances which it found beyond a reasonable doubt. If, after a*
35 *reasonable time for deliberation, the jury is unable to reach a verdict,*
36 *the judge shall dismiss the jury and impose a sentence of life without the*
37 *possibility of parole and shall commit the defendant to the custody of the*
38 *secretary of corrections. In nonjury cases, the court shall follow the*
39 *requirements of this subsection in determining the sentence to be*
40 *imposed.*

41 *(f) Notwithstanding the verdict of the jury, the trial court shall*
42 *review any jury verdict imposing a sentence of death hereunder to*
43 *ascertain whether the imposition of such sentence is supported by the*

1 *evidence. If the court determines that the imposition of such a sentence*
2 *is not supported by the evidence, the court shall modify the sentence and*
3 *sentence the defendant to life without the possibility of parole, and no*
4 *sentence of death shall be imposed hereunder. Whenever the court*
5 *enters a judgment modifying the sentencing verdict of the jury, the court*
6 *shall set forth its reasons for so doing in a written memorandum which*
7 *shall become part of the record.*

8 *(g) A defendant who is sentenced to imprisonment for life without*
9 *the possibility of parole shall spend the remainder of the defendant's*
10 *natural life incarcerated and in the custody of the secretary of*
11 *corrections. A defendant who is sentenced to imprisonment for life*
12 *without the possibility of parole shall not be eligible for commutation of*
13 *sentence, parole, probation, assignment to a community correctional*
14 *services program, conditional release, postrelease supervision, functional*
15 *incapacitation release pursuant to K.S.A. 22-3728, and amendments*
16 *thereto, or suspension, modification or reduction of sentence. Upon*
17 *sentencing a defendant to imprisonment for life without the possibility of*
18 *parole, the court shall commit the defendant to the custody of the*
19 *secretary of corrections and the court shall state in the sentencing order*
20 *of the judgment form or journal entry, whichever is delivered with the*
21 *defendant to the correctional institution, that the defendant has been*
22 *sentenced to imprisonment for life without the possibility of parole.*

24 follows: 21-6620. (a) (1) Except as provided in subsection (a)(2) and
25 K.S.A. 2013 Supp. 21-6618 and 21-6622, and amendments thereto, if a
26 defendant is convicted of the crime of capital murder and a sentence of
27 death is not imposed pursuant to subsection (e) of K.S.A. 2013 Supp. 21-
28 6617, and amendments thereto, or requested pursuant to subsection (a) or
29 (b) of K.S.A. 2013 Supp. 21-6617, and amendments thereto, the defendant
30 shall be sentenced to life without the possibility of parole.

31 ~~(2)—If a defendant is (A)~~ **Except as provided in subsection (a)(2)(B),**
32 **a defendant** convicted of attempt to commit the crime of capital murder;
33 ~~the defendant~~ shall be sentenced to imprisonment for life and shall not be
34 eligible for probation or suspension, modification or reduction of
35 sentence. In addition, the defendant shall not be eligible for parole prior
36 to serving 25 years' imprisonment, and such 25 years' imprisonment shall
37 not be reduced by the application of good time credits. No other sentence
38 shall be permitted.

39 **(B) The provisions of subsection (a)(2)(A) requiring the court to**
40 **impose a mandatory minimum term of imprisonment of 25 years shall**

8 upon the finding of premeditated murder, upon reasonable notice by the
9 prosecuting attorney, the court shall determine, in accordance with this
10 subsection, whether the defendant shall be required to serve a mandatory
11 minimum term of imprisonment of 50 years or sentenced as otherwise
12 provided by law.

13 (2) The court shall conduct a separate proceeding following the
14 determination of the defendant's guilt for the jury to determine whether
15 one or more aggravating circumstances exist. Such proceeding shall be
16 conducted by the court before a jury as soon as practicable. If any person
17 who served on the trial jury is unable to serve on the jury for the
18 proceeding, the court shall substitute an alternate juror who has been
19 impaneled for the trial jury. If there are insufficient alternate jurors to
20 replace trial jurors who are unable to serve at the proceeding, the court
21 may conduct such proceeding before a jury which may have 12 or less
22 jurors, but at no time less than six jurors. If the jury has been discharged
23 prior to the proceeding, a new jury shall be impaneled. Any decision of the
24 jury regarding the existence of an aggravating circumstance shall be
25 beyond a reasonable doubt. Jury selection procedures, qualifications of
26 jurors and grounds for exemption or challenge of prospective jurors in
27 criminal trials shall be applicable to the selection of such jury. The jury at
28 the proceeding may be waived in the manner provided by K.S.A. 22-3403,
29 and amendments thereto, for waiver of a trial jury. If the jury at the
30 proceeding has been waived, such proceeding shall be conducted by the
31 court.

32 (3) In the proceeding, evidence may be presented concerning any
33 matter relating to any of the aggravating circumstances enumerated in
34 K.S.A. 2013 Supp. 21-6624, and amendments thereto. Only such evidence
35 of aggravating circumstances as the prosecuting attorney has made known
36 to the defendant prior to the proceeding shall be admissible and no
37 evidence secured in violation of the constitution of the United States or of
38 the state of Kansas shall be admissible. No testimony by the defendant at
39 the time of the proceeding shall be admissible against the defendant at any
40 subsequent criminal proceeding. At the conclusion of the evidentiary
41 presentation, the court shall allow the parties a reasonable period of time in
42 which to present oral argument.

43 (4) At the conclusion of the evidentiary portion of the proceeding, the

1 court shall provide oral and written instructions to the jury to guide its
2 deliberations. If the prosecuting attorney relies on subsection (a) of K.S.A.
3 2013 Supp. 21-6624, and amendments thereto, as an aggravating
4 circumstance, and the court finds that one or more of the defendant's prior
5 convictions satisfy such subsection, the jury shall be instructed that a
6 certified journal entry of a prior conviction is presumed to prove the
7 existence of such prior conviction or convictions beyond a reasonable
8 doubt.

9 (5) If, by unanimous vote, the jury finds beyond a reasonable doubt
10 that one or more of the aggravating circumstances enumerated in K.S.A.
11 2013 Supp. 21-6624, and amendments thereto, exist, the jury shall
12 designate, in writing, signed by the foreman of the jury, the statutory
13 aggravating circumstances which it found. If, after a reasonable time for
14 deliberation, the jury is unable to reach a unanimous sentencing decision,
15 the court shall dismiss the jury and the defendant shall be sentenced as
16 provided by law. In nonjury cases, the court shall designate, in writing, the
17 specific circumstance or circumstances which the court found beyond a
18 reasonable doubt.

19 (6) If one or more of the aggravating circumstances enumerated in
20 K.S.A. 2013 Supp. 21-6624, and amendments thereto, are found to exist
21 beyond a reasonable doubt pursuant to this subsection, the defendant shall

7 ***(M) an attempt, conspiracy or criminal solicitation, as defined in***
8 ***K.S.A. 21-3301, 21-3302 or 21-3303, prior to their repeal, or K.S.A. 2013***
9 ***Supp. 21-5301, 21-5302 or 21-5303, and amendments thereto, of a***
10 ***sexually violent crime as defined in this section.***

11 ***(6) As used in this subsection, "sexually motivated" means that one***
12 ***of the purposes for which the defendant committed the crime was for the***

15 *safety. The board shall determine whether a hearing is necessary on the*

32 *supervised upon release, and shall have the authority to initiate*
33 *revocation of the person at any time for the reasons indicated in*

36 *shall be final and not subject to review by any administrative agency or*

9 **(c) Nothing in this section shall apply to the release of people with**
 10 **terminal medical conditions as described in K.S.A. 2013 Supp. 22-3729,**
 11 **and amendments thereto.**

12 **(d) This section does not apply to any person sentenced to**
 13 **imprisonment for an off-grid offense.**

14 **(e) This section does not apply to any person under sentence of death**
 15 **or life without the possibility of parole.**
