



#### What is KCJIS?

- KCJIS is a 24/7/365 secure electronic information service which connects different aspects
  of the criminal justice community and some agency's outside the criminal justice
  community.
  - · There is only one connection per state, Kansas Bureau of Investigation (KBI)
    - Some of the federal criminal justice systems are the FBI Interstate Identification Index (III), National Crime Information Center (NCIC) and National Instant Criminal Background Check System (NICS)
    - · Kansas Criminal History Information (KBI)
    - Kansas Driving Records and Kansas Vehicle Registration (KDOR)
    - · Kansas Warrants, Protection Orders, Stolen Property
    - KDOT Crash Reports
  - · Kansas Highway Patrol is the CJIS System Agency (CSA)
    - . Captain of Troop M, Captain Bramlett, is the CJIS System Officer (CSO) for Kansas
  - International Justice for Public Safety Network (NLETS)
    - Used for out of state drivers license and registration information is securely transmitted
    - Connection to Interpol and Canadian drivers license and registration information

### **KCJIS Committee**

- The mission of the KCJIS Committee is to establish, maintain, upgrade and enhance the criminal
  justice information system as authorized. The committee is composed of 10 different
  representatives from different portions of the criminal justice community. (K.S.A. 74-5701)

## **KCJIS** Committee

- KCJIS Committee typically meets at 1:30 the 2<sup>nd</sup> Monday of each month at the Kansas Judicial Center
- · KCJIS Executive Committee appoints the Director with the approval of the full committee
  - · Gordon Lansford
- KCJIS Policy and Procedure Manual is annually updated and maintained by the KCJIS
   Committee
  - The FBI Criminal Justice Services (CJIS) Security Policy is the format and minimum standard.
  - The Committee adds specific language and requirements to create the KCJIS Policy and Procedure Manual.

# Kansas Highway Patrol's role within the Kansas Criminal Justice Information System (KCJIS)

- Criminal Justice Information Services Systems Officer (CSO)
- Train and test all NCIC Kansas Terminal Agency Coordinators (TAC's)
- Conduct triennial audits of Terminal Agency's
- Conduct triennial Technical Security Audits on Terminal Agency's
- Offer Security Awareness training
- Audit users that access National Data Exchange (N-DEx)
- Conduct record checks on select contractors and vendors.

# Kansas Highway Patrol Central Communications

## KHP Central Communications

- Located in Salina in the Troop C building
- 64 Full time employee positions
- Staffed 24/7/365
- Maintain Remote sight locations as back-up locations
  - Radio Console
  - Dispatch Console
- Have 7 laptops and MiFi devices as a back-up in Salina.
- Generator and Uninterruptable Power Supply

## KHP Central Communications

- Ability to use MOTOBRIDGE system on K-DOT's 76 tower sites.
- This system can connect or "patch" pre-determined channels of different radio systems and frequencies.
  - VHF Low Band
  - · VHF High Band
  - UHF
  - 800 MHz
  - KHP Event Talkgroups
- MOTOBRIDGE system is intended for multi-disciplinary and multi-jurisdictional use when other common means of radio communications are not available.

## KHP Central Communications

- Answer Safe School Hotline and referrals.
- · Report underage drinking Hotline and referrals.
- Answer HAZMAT toll free number after normal business hours.
- Weather information motorist and consult KDOT 511
- · KDOT tower alarms, notification and cancellation of NOTAMS
- Facility alarm monitoring and notifications
