1 AN ACT concerning schools; relating to career technical education
2 awards; amending K.S.A. 2014 Supp. 72-4489 and repealing the
3 existing section.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2014 Supp. 72-4489 is hereby amended to read as
7 follows: 72-4489. (a) The state board of regents shall establish the career
8 technical education incentive program.

9 (b) (1) Each school year, to the extent there are sufficient moneys
10 appropriated to the career technical education incentive program, the state
11 board of regents shall make an award to those school districts who have at
12 least one pupil who graduates from a high school in the school district
13 having obtained an industry-recognized credential either prior to
14 graduation from high school or by December 31 immediately following
15 graduation from high school in an occupation that has been identified by
16 the secretary of labor, in consultation with the state board of regents and
17 the state board of education, as an occupation in highest need of additional
18 skilled employees at the time the pupil entered the career technical
19 education course or program in the school district. Such school districts
20 shall receive an award in an amount equal to ~~\$1,000~~ *\$250 plus the cost of*
21 ~~each successful completion of an industry-recognized credential~~
22 ~~assessment~~ **\$1,000** for each such pupil graduating from a high school in
23 the school district. **If the amount of moneys to be awarded to such**
24 **school districts exceeds the amount of moneys appropriated to the**
25 **career technical education incentive program, the board of regents**
26 **shall prorate the available moneys.** Such awards shall be paid at such
27 times as established by the state board of regents. ~~The total aggregate~~
28 ~~amount of such awards shall not exceed \$750,000 per school year.~~ Such
29 awards shall be expended for the expenses incurred by the board of
30 education of the school district under this subsection, and any moneys
31 remaining after distribution in accordance with this subsection may be
32 expended as determined by the board of education of a school district
33 towards operating the school from which the pupils graduated. Upon
34 receipt of such award and application by a pupil who has not attained a
35 high school diploma and is currently or was previously enrolled in a career
36 technical education course or program in the school district, the board of

1 education of each school district shall pay $\frac{1}{2}$ of the costs of the industry-
2 recognized credential assessment specified in such application in an
3 amount not to exceed \$1,000. Such industry-recognized credential
4 assessment shall be related to the career technical education course or
5 program which such pupil is currently or was previously enrolled as
6 determined by the board of education. No board of education shall be
7 required to pay $\frac{1}{2}$ of the cost of three or more industry-recognized
8 credential assessments for the same or substantially the same industry-
9 recognized credential for a pupil if such pupil fails to earn the industry-
10 recognized credential within two attempts of taking the industry-
11 recognized credential assessment.

12 (2) The state board of education shall certify to the state board of
13 regents and the director of accounts and reports the amounts due to each
14 school district pursuant to this subsection. Such certification, and the
15 amount payable, shall be approved by the director of the budget. The
16 director of accounts and reports shall draw warrants on the state treasurer
17 payable to the district treasurer of each school district entitled to payment
18 of such award amount, pursuant to vouchers approved by the state board of
19 regents. Upon receipt of such warrant, each district treasurer shall deposit
20 the amount of such award in the general fund of the school district.

21 (c) (1) Each school year, to the extent there are sufficient moneys
22 appropriated to the career technical education incentive program, the state
23 board of regents shall make an award to a community college, technical
24 college or institute of technology who has at least one secondary student
25 who is currently or was previously admitted to a career technical education
26 course or program in accordance with ~~subsection (c) of K.S.A. 72-4417(c),~~
27 and amendments thereto, and such secondary student is regularly enrolled
28 in and attending a private secondary school. The purpose of such award is
29 to reimburse such community college, technical college or institute of
30 technology for paying $\frac{1}{2}$ of the costs of an industry-recognized credential
31 assessment in an occupation that has been identified by the secretary of
32 labor, in consultation with the state board of regents and the state board of
33 education, as an occupation in highest need of additional skilled
34 employees at the time the secondary student was admitted into such career
35 technical education course or program. Upon receipt of such award and
36 application by a secondary student who is currently or was previously
37 enrolled in a career technical education course or program in accordance
38 with ~~subsection (c) of K.S.A. 72-4417(c),~~ and amendments thereto, and is
39 regularly enrolled in and attending a private secondary school, the
40 governing body of the community college, technical college or the institute
41 of technology which admitted such secondary student shall pay $\frac{1}{2}$ of the
42 costs of the industry-recognized credential assessment specified in such
43 application in an amount not to exceed \$1,000. Such industry-recognized

1 credential assessment shall be related to the career technical education
2 course or program in which such secondary student is currently or was
3 previously enrolled as determined by such governing body of a community
4 college, technical college or institute of technology. No governing body of
5 a community college, technical college or institute of technology shall be
6 required to pay $\frac{1}{2}$ of the cost of three or more industry-recognized
7 credential assessments for the same or substantially the same industry-
8 recognized credential for a secondary student if such secondary student
9 fails to earn the industry-recognized credential within two attempts of
10 taking the industry-recognized credential assessment.

11 (2) Each governing body of a community college, technical college or
12 institute of technology shall certify to the state board of regents the amount
13 of any payments such community college, technical college or institute of
14 technology will pay based on applications submitted by students pursuant
15 to paragraph (1). The certification shall be on a form prescribed and
16 furnished by the state board of regents, shall contain such information as
17 the state board of regents shall require and shall be filed at the time
18 specified by the state board of regents.

19 (3) In each school year, each governing body of a community college,
20 technical college or institute of technology is entitled to receive from
21 appropriations for the career technical education incentive program an
22 amount which is equal to the amount certified to the state board of regents
23 in accordance with the provisions of paragraph (2). The state board of
24 regents shall certify to the director of accounts and reports the amount due
25 each governing body of a community college, technical college or institute
26 of technology. The director of accounts and reports shall draw warrants on
27 the state treasurer payable to the treasurer of each governing body of a
28 community college, technical college or institute of technology entitled to
29 payment under this subsection upon vouchers approved by the state board
30 of regents.

31 (4) Moneys received by a state board of regents under this subsection
32 shall be deposited in the postsecondary technical education fund of each
33 community college and at Washburn university for the Washburn institute
34 of technology or the general operating fund in the technical college in
35 accordance with K.S.A. 2014 Supp. 71-1808, and amendments thereto,
36 and shall be considered reimbursements to the community college,
37 technical college or institute of technology.

38 (d) Each school year, at such time as agreed to by the secretary of
39 labor, the president of the state board of regents and the commissioner of
40 education, the secretary shall provide the state board of regents and the
41 state board of education with a list of those occupations in highest need of
42 additional skilled employees. If the occupations identified in such list are
43 not substantially the same as those occupations identified in the list from

1 the prior year, reasonable notice of such changes shall be provided to
2 school districts, community colleges, technical colleges and the institute of
3 technology.

4 (e) The state board of regents and the state board of education, jointly,
5 may adopt such rules and regulations necessary to implement and carry out
6 the provisions of this section.
