1 AN ACT concerning postsecondary education; relating to postsecondary
2 career technical education performance-based funding; amending
3 K.S.A. 2015 Supp. 72-4490 and repealing the existing section.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2015 Supp. 72-4490 is hereby amended to read as
7 follows: 72-4490. (a) (1) Any eligible postsecondary educational
8 institution may certify to the board of regents:

9 (A) The number of individuals who received a general educational
10 development (GED) credential from such institution ~~while enrolled in an~~
11 ~~eligible career technical education program while enrolled in an eligible~~
12 **career technical education program;**

13 (B) the number of individuals who received a career technical
14 education credential from such institution; and

15 (C) the number of individuals who were enrolled in an eligible career
16 technical education program at such institution and who are pursuing a
17 general educational development (GED) credential.

18 ~~(2) A student shall not be required to be dual enrolled in a general-~~
19 ~~educational development (GED) credential program and an eligible-~~
20 ~~career technical education program in order to be counted by an eligible-~~
21 ~~postsecondary educational institution pursuant to this subsection.~~

22 ~~(3)~~—Certifications submitted pursuant to this subsection shall be
23 submitted in such form and manner as prescribed by the board of regents,
24 and shall include such other information as required by the board of
25 regents.

26 (b) Each fiscal year, upon receipt of a certification submitted under
27 subsection (a), the board of regents shall authorize payment to such
28 eligible postsecondary educational institution from the postsecondary
29 education performance-based incentives fund. The amount of any such
30 payment shall be calculated based on the following:

31 (1) For each individual who has received a general educational
32 development (GED) credential, \$500;

33 (2) for each individual who has received a career technical education
34 credential, \$1,000; and

35 (3) for each individual enrolled in an eligible career technical
36 education program who is pursuing a general educational development

1 (GED) credential, \$170.

2 (c) That portion of any payment from the postsecondary education
3 performance-based incentives fund that is made based on subsection (b)(2)
4 shall be expended for scholarships for individuals enrolled in an eligible
5 career technical education program and operating costs of eligible career
6 technical education programs. Each eligible postsecondary educational
7 institution shall prepare and submit a report to the board of regents which
8 shall include the number of individuals who received scholarships, the
9 aggregate amount of moneys expended for such scholarships and the
10 number of those individuals who received a scholarship that also received
11 a career technical education credential.

12 (d) (1) Of that portion of any payment from the postsecondary
13 education performance-based incentives fund that is made based on
14 subsection (b)(3), an amount equal to \$150 for each individual shall be
15 expended by the eligible postsecondary educational institution for the
16 general educational development (GED) test.

17 (2) If any individual enrolled in an eligible career technical education
18 program for which an eligible postsecondary educational institution has
19 received a payment under this section fails to take the general educational
20 development (GED) test, then such institution shall notify the board of
21 regents in writing that no such test was administered to the individual. For
22 each such notification received, the board of regents shall deduct an
23 amount equal to \$150 from such institution's subsequent incentive
24 payment.

25 (e) All payments authorized by the board of regents pursuant to this
26 section shall be subject to the limits of appropriations made for such
27 purposes. If there are insufficient appropriations for the board of regents to
28 authorize payments in accordance with the amounts set forth in subsection
29 (b), the board of regents shall prorate such amounts in accordance with
30 appropriations made therefor.

31 (f) There is hereby created the postsecondary education performance-
32 based incentives fund. Expenditures from the postsecondary education
33 performance-based incentives fund shall be for the sole purpose of paying
34 payments to eligible postsecondary educational institutions as authorized
35 by the board of regents. All expenditures from the postsecondary education
36 performance-based incentives fund shall be made in accordance with
37 appropriation acts upon warrants of the director of accounts and reports
38 issued pursuant to vouchers approved by the president of the board of
39 regents, or the president's designee.

40 (g) As used in this section:

41 (1) "Board of regents" means the state board of regents provided for
42 in the constitution of this state and established by K.S.A. 74-3202a, and
43 amendments thereto.

1 (2) "Career technical education credential" means any industry-
2 recognized technical certification or credential, other than a general
3 educational development (GED) credential, or any technical certification
4 or credential authorized by a state agency.

5 (3) "Eligible career technical education program" means a program
6 operated by one or more eligible postsecondary educational institutions
7 that is identified by the board of regents as a program that allows an
8 enrollee to obtain a general educational development (GED) credential
9 while pursuing a career technical education credential.

10 (4) "Eligible postsecondary educational institution" means any
11 community college, technical college or the institute of technology at
12 Washburn university, ~~except such term shall not include Johnson county~~
13 ~~community college.~~

14 (5) "State agency" means any state office, department, board,
15 commission, institution, bureau or any other state authority.

16 Sec. 2. K.S.A. 2015 Supp. 72-4490 is hereby repealed.

17 Sec. 3. This act shall take effect and be in force from and after its
18 publication in the statute book.
