1 AN ACT concerning motor vehicles; relating to commercial vehicles;
2 motor carriers; regulation; amending K.S.A. 2014 Supp. 66-1,109 and
3 66-1,129 and repealing the existing sections.
4

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2014 Supp. 66-1,109 is hereby amended to read as
7 follows: 66-1,109. This act shall not require the following carriers to
8 obtain a certificate, license or permit from the commission or file rates,
9 tariffs, annual reports or provide proof of insurance with the commission:

10 (a) Transportation by motor carriers wholly within the corporate
11 limits of a city or village in this state, or between contiguous cities or
12 villages in this state or in this and another state, or between any city or
13 village in this or another state and the suburban territory in this state within
14 three miles of the corporate limits, or between cities and villages in this
15 state and cities and villages in another state which are within territory
16 designated as a commercial zone by the relevant federal authority, except
17 that none of the exemptions specified in this subsection (a) shall apply to
18 wrecker carriers;

19 (b) a private motor carrier who operates within a radius of 25 miles
20 beyond the corporate limits of its city or village of domicile, or who
21 operates between cities and villages in this state and cities and villages in
22 another state which are within territory designated as a commercial zone
23 by the relevant federal authority. *For the purpose of this subsection,*
24 *"domicile" shall mean the principal place of business of a motor carrier;*

25 (c) the owner of livestock or producer of farm products transporting
26 livestock of such owner or farm products of such producer to market in a
27 motor vehicle of such owner or producer, or the motor vehicle of a
28 neighbor on the basis of barter or exchange for service or employment, or
29 to such owner or producer transporting supplies for the use of such owner
30 or producer in a motor vehicle of such owner or producer, or in the motor
31 vehicle of a neighbor on the basis of barter or exchange for service or
32 employment;

33 (d) (1) the transportation of children to and from school; (2) to motor
34 vehicles owned by schools, colleges, and universities, religious or
35 charitable organizations and institutions, or governmental agencies, when
36 used to convey students, inmates, employees, athletic teams, orchestras,

1 bands or other similar activities; or (3) motor vehicles owned by nonprofit
2 organizations meeting the qualification requirements of section 501(c) of
3 the internal revenue code of 1986, and amendments thereto, when
4 transporting property or materials belonging to the owner of the vehicle;

5 (e) a new vehicle dealer as defined by K.S.A. 8-2401, and
6 amendments thereto, when transporting property to or from the place of
7 business of such dealer;

8 (f) motor vehicles carrying tools, property or material belonging to
9 the owner of the vehicle and used in repair, building or construction work,
10 not having been sold or being transported for the purpose of sale;

11 (g) persons operating motor vehicles which have an ad valorem tax
12 situs in and are registered in the state of Kansas, and used only to transport
13 grain from the producer to an elevator or other place for storage or sale for
14 a distance of not to exceed 50 miles;

15 (h) the operation of hearses, funeral coaches, funeral cars or
16 ambulances by motor carriers;

17 (i) motor vehicles owned and operated by the United States, the
18 District of Columbia, any state, any municipality or any other political
19 subdivision of this state, including vehicles used exclusively for handling
20 U.S. mail, and the operation of motor vehicles used exclusively by
21 organizations operating public transportation systems pursuant to 49
22 U.S.C. ~~sections~~ §§ 5307, 5310 and 5311;

23 (j) any motor vehicle with a normal seating capacity of not more than
24 the driver and 15 passengers while used for vanpooling or otherwise not-
25 for-profit in transporting persons who, as a joint undertaking, bear or agree
26 to bear all the costs of such operations, or motor vehicles with a normal
27 seating capacity of not more than the driver and 15 passengers for not-for-
28 profit transportation by one or more employers of employees to and from
29 the factories, plants, offices, institutions, construction sites or other places
30 of like nature where such persons are employed or accustomed to work;

31 (k) motor vehicles used to transport water for domestic purposes, as
32 defined by ~~subsection (e) of~~ K.S.A. 82a-701(c), and amendments thereto,
33 or livestock consumption;

34 (l) transportation of sand, gravel, slag stone, limestone, crushed stone,
35 cinders, calcium chloride, bituminous or concrete mixtures, blacktop, dirt
36 or fill material to a construction site, highway maintenance or construction
37 project or other storage facility and the operation of ready-mix concrete
38 trucks in transportation of ready-mix concrete;

39 (m) the operation of a vehicle used exclusively for the transportation
40 of solid waste, as the same is defined by K.S.A. 65-3402, and amendments
41 thereto, to any solid waste processing facility or solid waste disposal area,
42 as the same is defined by K.S.A. 65-3402, and amendments thereto;

43 (n) the transporting of vehicles used solely in the custom combining

1 business when being transported by persons engaged in such business;

2 (o) the operation of vehicles used for servicing, repairing or
3 transporting of implements of husbandry, as defined in K.S.A. 8-1427, and
4 amendments thereto, by a person actively engaged in the business of
5 buying, selling or exchanging implements of husbandry, if such operation
6 is within 100 miles of such person's established place of business in this
7 state;

8 (p) transportation by taxi or bus companies operated exclusively
9 within any city or within 25 miles of the point of its domicile in a city. *For*
10 *the purpose of this subsection, "domicile" shall mean the principal place*
11 *of business of a motor carrier;*

12 (q) a vehicle being operated with a dealer license plate issued under
13 K.S.A. 8-2406, and amendments thereto, and in compliance with K.S.A. 8-
14 136, and amendments thereto, and vehicles being operated with a full-
15 privilege license plate issued under K.S.A. 8-2425, and amendments
16 thereto;

17 (r) the operation of vehicles used for transporting materials used in
18 the servicing or repairing of the refractory linings of industrial boilers;

19 (s) transportation of newspapers published at least one time each
20 week;

21 (t) transportation of animal dung to be used for fertilizer;

22 (u) the operation of ground water well drilling rigs;

23 (v) the transportation of cotton modules from the field to the gin; ~~and~~

24 (w) the transportation of custom harvested silage, including, but not
25 limited to, corn, wheat and milo; and

26 ~~(x) commercial motor vehicles operating in intrastate commerce~~
27 ~~which do not equal or exceed a gross vehicle weight (GVW), gross vehicle~~
28 ~~weight rating (GVWR), gross combination weight (GCW) or gross~~
29 ~~combination weight rating (GCWR) of 26,001 pounds, except commercial~~
30 ~~motor vehicles, regardless of weight, which are designed or used to~~
31 ~~transport 16 or more passengers, including the driver, or which are used in~~
32 ~~the transportation of hazardous materials and required to be placarded~~
33 ~~pursuant to 49 C.F.R. part 172, subpart F. The provisions of this subsection~~
34 ~~shall expire and have no effect on and after July 1, 2015 private motor~~
35 ~~carriers domiciled in Kansas operating commercial motor vehicles (CMV)~~
36 ~~with a gross vehicle weight (GVW), gross vehicle weight rating (GVWR),~~
37 ~~gross combination weight (GCW), or gross combination weight rating~~

1 *required to be placarded pursuant to 49 C.F.R. part 172, subpart F. For*
2 *the purpose of this subsection, "domicile" shall mean the principal place*
3 *of business of a motor carrier or a permanent location in Kansas for a*
4 *vehicle or vehicles annually registered in Kansas.*

5 Sec. 2. K.S.A. 2014 Supp. 66-1,129 is hereby amended to read as
6 follows: 66-1,129. (a) The commission shall adopt rules and regulations
7 necessary to carry out the provisions of this act. No public motor carrier of
8 property, household goods or passengers or private motor carrier of
9 property shall operate or allow the operation of any motor vehicle on any
10 public highway in this state except within the provisions of the rules and
11 regulations adopted by the commission. Rules and regulations adopted by
12 the commission shall include:

13 (1) Every vehicle unit shall be maintained in a safe and sanitary
14 condition at all times.

15 (2) Every driver of a public or private motor carrier, except the driver
16 of a farm vehicle, operating as a carrier of intrastate commerce within this
17 state, shall be at least 18 years of age. All such drivers shall be competent
18 to operate the motor vehicle under such driver's charge.

19 (3) Minimum age requirements for every driver of a motor carrier,
20 operating as a carrier of interstate commerce, shall be consistent with
21 federal motor carrier regulations.

22 (4) Hours of service for operators of all motor carriers to which this
23 act applies shall be fixed by the commission.

24 (5) Accidents arising from or in connection with the operation of
25 motor carriers shall be reported to the commission within the time, in the
26 detail and in the manner as the commission requires.

27 (6) Every motor carrier shall have attached to each unit or vehicle
28 distinctive marking adopted by the commission.

29 (7) Motor carrier transportation requirements that are consistent with
30 continuation of the federal motor carrier safety assistance program and
31 other federal requirements concerning transportation of hazardous
32 materials.

33 (b) No rules and regulations adopted by the commission pursuant to
34 this section shall require the operator of any motor vehicle having a gross
35 vehicle weight rating or gross combination weight rating of not more than
36 10,000 pounds to submit to a physical examination, unless required by
37 federal laws or regulations.

38 ~~(c) Any rules and regulations of the commission, adopted pursuant to~~
39 ~~this section, The provisions of 49 C.F.R. parts 390-399 adopted by~~
40 ~~reference in the rules and regulations of the commission shall not apply to~~
41 ~~the following, while engaged in the carriage of intrastate commerce in this~~
42 ~~state:~~

43 (1) The owner of livestock or producer of farm products transporting

1 livestock of such owner or farm products of such producer to market in a
2 motor vehicle of such owner or producer, or the motor vehicle of a
3 neighbor on the basis of barter or exchange for service or employment, or
4 to such owner or producer transporting supplies for the use of such owner
5 or producer in or producer, or in the motor vehicle of a neighbor on the
6 basis of barter or exchange for service or employment.

7 (2) The transportation of children to and from school, or to motor
8 vehicles owned by schools, colleges, and universities, religious or
9 charitable organizations and institutions, or governmental agencies, when
10 used to convey students, inmates, employees, athletic teams, orchestras,
11 bands or other similar activities.

12 ~~(3) Commercial motor vehicles operating in intrastate commerce~~
13 ~~which do not equal or exceed a gross vehicle weight (GVW), gross vehicle~~
14 ~~weight rating (GVWR), gross combination weight (GCW) or gross~~
15 ~~combination weight rating (GCWR) of 26,001 pounds, except commercial~~
16 ~~motor vehicles, regardless of weight, which are designed or used to~~
17 ~~transport 16 or more passengers, including the driver, or which are used in~~
18 ~~the transportation of hazardous materials and required to be placarded~~
19 ~~pursuant to 49 C.F.R. part 172, subpart F. Notwithstanding the exemption~~
20 ~~granted under this paragraph, all commercial motor vehicles shall comply~~
21 ~~with 49 C.F.R. part 393, subpart I, as adopted by K.A.R. 82-4-3i, and 49~~
22 ~~C.F.R. § 396.17, as adopted by K.A.R. 82-4-3j. Vehicles found to be in~~
23 ~~violation of 49 C.F.R. part 393, subpart I, as adopted by K.A.R. 82-4-3i,~~
24 ~~prior to October 1, 2014, shall be issued a warning citation. Vehicles found~~
25 ~~to be in violation of 49 C.F.R. § 396.17, as adopted by K.A.R. 82-4-3j,~~
26 ~~prior to July 1, 2015, shall be issued a warning citation. The provisions of~~
27 ~~this paragraph shall expire and have no effect on and after July 1,~~
28 ~~2015.~~
29 *Private motor carriers domiciled in Kansas operating commercial*
30 *motor vehicles (CMV) with a gross vehicle weight (GVW), gross vehicle*
31 *weight rating (GVWR), gross combination weight (GCW), or gross*
32 *combination weight rating (GCWR) of 10,001 to 26,000 pounds and*
33 *registered pursuant to K.S.A. 8-126 et seq., and amendments thereto. Such*
34 *carriers shall comply with 49 C.F.R. part 393, subpart I (load securement)*
35 *and subpart F (coupling devices), as adopted by K.A.R. 82-4-3i; and 49*
36 *C.F.R. part 396.17 (annual inspection), as adopted by K.A.R. 82-4-3j. Any*
37 *deficiencies related to the above regulations discovered roadside or any*
38 *defects identified at the time of the annual inspection shall be corrected*
39 *prior to returning the commercial motor vehicle to operational status. This*
40 *exception does not apply to commercial motor vehicles, regardless of*
41 *weight, which are designed or used to transport 16 or more passengers,*
42 *including the driver, or intrastate public (for hire) motor carriers of*
43 *property or passengers, or any motor vehicles which are used in the*
transportation of hazardous materials and required to be placarded

1 *pursuant to 49 C.F.R. part 172, subpart F. For the purpose of this*
2 *subsection "domicile" shall mean the principal place of business of a*
3 *motor carrier or a permanent location in Kansas for a vehicle or vehicles*
4 *annually registered in Kansas.*

5 (4) Persons operating motor vehicles which have an ad valorem tax
6 situs in and are registered in the state of Kansas, and used only to transport
7 grain from the producer to an elevator or other place for storage or sale for
8 a distance of not to exceed 50 miles.

9 (5) The operation of hearses, funeral coaches, funeral cars or
10 ambulances by motor carriers.

11 (6) Motor vehicles owned and operated by the United States, the
12 District of Columbia, any state, any municipality or any other political
13 subdivisions of this state.

14 (7) Any motor vehicle with a normal seating capacity of not more
15 than 15 people, including the driver, while used for vanpooling or
16 otherwise not-for-profit in transporting persons who, as a joint
17 undertaking, bear or agree to bear all the costs of such operations, or motor
18 vehicles with a normal seating capacity of not more than 15 people,
19 including the driver, for not-for-profit transportation by one or more
20 employers of employees to and from the factories, plants, offices,
21 institutions, construction sites or other places of like nature where such
22 persons are employed or accustomed to work.

23 (8) The operation of vehicles used for servicing, repairing or
24 transporting of implements of husbandry, as defined in K.S.A. 8-1427, and
25 amendments thereto, by a person actively engaged in the business of
26 buying, selling or exchanging implements of husbandry, if such operation
27 is within 100 miles of such person's established place of business in this
28 state, unless the implement of husbandry is transported on a commercial
29 motor vehicle.

30 Sec. 3. K.S.A. 2014 Supp. 66-1,109 and 66-1,129 are hereby
31 repealed.
