1 AN ACT concerning the legislature; relating to regular sessions;
2 legislators' compensation; amending K.S.A. ~~46-137e, 46-157 and 75-~~
3 ~~3212 and K.S.A. 2015 Supp. 46-137a~~ and repealing the existing
4 sections *{section}*.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. K.S.A. 46-157 is hereby amended to read as follows: 46-
8 157. (a) The senate and the house of representatives shall convene in
9 regular session of the legislature annually at 2:00 o'clock p.m. of the
10 second Monday of January.

11 (b) *The duration of regular sessions held in odd-numbered years*
12 *shall not exceed 100 calendar days and the duration of regular sessions*
13 *held in even-numbered years shall not exceed 60 calendar days. Such*
14 *sessions may be extended by an affirmative vote of two-thirds of the*
15 *members elected or appointed to each house.*

16 Sec. 2. ~~K.S.A. 2015 Supp. 46-137a is hereby amended to read as~~
17 ~~follows: 46-137a. In addition to the compensation provided for by K.S.A.~~
18 ~~46-137b, 46-137e and 75-3212, and amendments thereto, each member of~~
19 ~~the legislature shall receive the following amounts:~~

20 (a) ~~On July 1, 2016, during even-numbered years, the sum of \$5,400~~
21 ~~for the regular session, during odd-numbered years, the sum of \$8,800 for~~
22 ~~the regular session, and the sum of \$88.66 per calendar day for service at~~
23 ~~any regular or special session, except as otherwise provided in subsection~~
24 ~~(c). The director of legislative administrative services shall determine~~
25 ~~payment of such amount for service at any regular session as a sum paid~~
26 ~~per pay period on a per calendar day basis calculated using the maximum~~
27 ~~number of calendar days specified in K.S.A. 46-157(b), and amendments~~
28 ~~thereto, for a regular session;~~

29 (b) ~~the sum of \$109 per calendar day for subsistence allowance for~~
30 ~~any regular or special session of the legislature, except that if the amounts~~
31 ~~allowable for the capital city of Kansas under applicable federal law and~~
32 ~~regulations to employees of the executive branch of the federal~~
33 ~~government for per diem expenses, while away from home but serving in~~
34 ~~the United States, are amounts which total greater than \$109, then each~~
35 ~~member of the legislature shall receive such greater total amount per~~
36 ~~calendar day for subsistence allowance for any regular or special session~~

1 of the legislature;

2 (e) ~~an allowance of \$354.15 for the two-week period which coincides~~
3 ~~with the biweekly payroll period which includes April 1st and for each of~~
4 ~~the 19 ensuing two-week periods thereafter, to defray expenses incurred~~
5 ~~between sessions of the legislature for postage, telephone, office and other~~
6 ~~incidental expenses, except as otherwise provided in subsection (f);~~

7 (d) ~~an allowance for mileage in an amount equal to the rate per mile~~
8 ~~prescribed under the provisions of K.S.A. 75-3203a, and amendments~~
9 ~~thereto, multiplied by the number of miles traveled by the usual route in~~
10 ~~going to and returning from the member's place of residence for any~~
11 ~~regular or special session of the legislature. Such mileage allowances shall~~
12 ~~be paid for not to exceed the equivalent of one trip for each full week~~
13 ~~occurring between convening and adjournment sine die in any regular or~~
14 ~~special session. The mileage allowance provided under the provisions of~~
15 ~~this subsection shall not be subject to the restrictions relating to the use of~~
16 ~~vehicles prescribed by K.S.A. 75-3203 and 75-3203a, and amendments~~
17 ~~thereto, but shall only be allowed for trips actually made. Compensation~~
18 ~~during a special session and subsistence allowance during a regular or~~
19 ~~special session shall not be allowed under the provisions of subsections (a)~~
20 ~~and (b) of this section during any period in which the legislature is~~
21 ~~adjourned for more than two days, Sundays excepted; and~~

22 (e) ~~whenever the rates of compensation of the pay plan for persons in~~
23 ~~the classified service under the Kansas civil service act are increased for~~
24 ~~payroll periods chargeable to fiscal years commencing after June 30, 2009,~~
25 ~~the rate of compensation per calendar day for members of the legislature~~
26 ~~for service at any regular or special session of the legislature shall be~~
27 ~~increased on the effective date of any such pay plan increase by an amount~~
28 ~~computed by multiplying the average of the percentage increases in all~~
29 ~~steps of such pay plan by the rate of compensation per calendar day which~~
30 ~~is authorized by this section for service at any regular or special session of~~
31 ~~the legislature for the day upon which such increase is computed.~~

32 (f) ~~Whenever the rates of compensation of the pay plan for persons in~~
33 ~~the classified service under the Kansas civil service act are increased for~~
34 ~~payroll periods chargeable to fiscal years commencing after June 30, 2009,~~
35 ~~the allowance provided for each member of the legislature by subsection~~
36 ~~(e) to defray expenses incurred between sessions of the legislature for~~
37 ~~postage, telephone, office and other incidental expenses for each of the~~
38 ~~two-week periods specified by subsection (e) shall be increased on the~~
39 ~~effective date of any such pay plan increase by an amount computed by~~
40 ~~multiplying the average of the percentage increases in all steps of such pay~~
41 ~~plan by the allowance provided to defray such expenses for each such two-~~
42 ~~week period as provided by this section.~~

43 Sec. 3.—K.S.A. 46-137e is hereby amended to read as follows: 46-

1 ~~137e. (a) The officers specified in K.S.A. 46-137b, and amendments~~
2 ~~thereto, shall, in addition to all other compensation and expense~~
3 ~~allowances authorized by law, receive compensation at the rate specified in~~
4 ~~clause (a) of K.S.A. 75-3212(a), and amendments thereto, per calendar~~
5 ~~day for service at any special session and subsistence allowances at the~~
6 ~~rates specified in clauses (b) and (c) of K.S.A. 75-3212(b) and (c), and~~
7 ~~amendments thereto, for each day (or part thereof), in the performance of~~
8 ~~the duties of their respective offices in Topeka and in addition thereto the~~
9 ~~mileage allowance specified in clause (d) of said K.S.A. 75-3212(d), and~~
10 ~~amendments thereto.~~

11 (b) When authorized by the legislative coordinating council to attend
12 to any legislative business in Topeka when the legislature is not in session,
13 members of the legislature not specified in subsection (a) of this section
14 shall, in addition to all other compensation and expenses authorized by
15 law, receive compensation, subsistence and mileage allowances in the
16 amounts specified in K.S.A. 75-3212, and amendments thereto.

17 (c) No compensation or subsistence or mileage allowances shall be
18 paid under this section for any day that a member is entitled to receive
19 compensation under K.S.A. 46-137a or K.S.A. 75-3212, and amendments
20 thereto.

21 Sec. 4. K.S.A. 75-3212 is hereby amended to read as follows: 75-
22 3212. In addition to amounts authorized under K.S.A. 46-137a, 46-137b
23 and 46-137c, and amendments thereto, members of the senate and the
24 house of representatives of the state and other persons or officers of
25 various committees, delegations, subcommittees, boards, commissions and
26 councils referred to in this act shall be paid compensation and travel
27 expenses and subsistence expenses or allowance for such service as
28 follows: (a) A per diem compensation of thirty-five dollars (\$35) for each
29 day of actual attendance at authorized in-state or out-of-state meetings
30 except that members of the senate and the house of representatives shall
31 receive per diem compensation therefor in the amount prescribed under
32 subsection (a) of K.S.A. 46-137a or any(a), and amendments thereto, for
33 service at any special session; (b) the sum specified in subsection (b) of
34 K.S.A. 46-137a or any(b), and amendments thereto, for subsistence
35 allowance per any day or part thereof spent in actual attendance at any
36 such in-state meeting; (c) for any day, or part thereof, other than the day of
37 the meeting, the sum specified in subsection (b) of K.S.A. 46-137a or
38 any(b), and amendments thereto, for subsistence allowance incurred in
39 going to and returning from such in-state meetings, provided such person
40 resides more than one hundred (100) miles from the location of the
41 meeting; (d) the mileage rate authorized by K.S.A. 75-3203a or any, and
42 amendments thereto, for each mile actually traveled by the usual route in
43 going to and returning from the place where an authorized in-state meeting

1 is held; and (c) the sum specified in K.S.A. 46-137a, and any amendments
2 thereto, for subsistence allowance per day or part thereof while attending
3 and going to and from any out-of-state meeting authorized by the
4 chairperson or the rules of the commission, committee or council, or as
5 otherwise authorized in accordance with this act or if the actual
6 subsistence expenses of such officer are in excess of the allowance
7 prescribed such officer shall be entitled to be reimbursed for such officer's
8 actual subsistence expenses incurred while attending such out-of-state
9 meeting. Such officers shall also be entitled to mileage allowances at the
10 rate authorized by K.S.A. 75-3203a or any, *and* amendments thereto, for
11 each mile actually traveled by the usual route in going to and returning
12 from the place of any such out-of-state meetings if private conveyance is
13 used, or actual transportation cost if private conveyance is not used. *No*
14 *legislator shall receive compensation under this section during any*
15 *regular legislative session.* No legislator shall receive compensation under
16 this section during any *special* legislative session, except when the
17 legislature is adjourned for a period of more than two days, Sundays
18 excepted. No legislator shall receive subsistence expenses or allowances
19 under this section for attendance at any in-state meeting during any
20 legislative session or for which subsistence expenses or allowances are
21 authorized under the provisions of K.S.A. 46-137e, *and amendments*
22 *thereto.* The total of both subsistence expenses and allowances allowed
23 under this section during a legislative session and subsistence allowances
24 allowed under K.S.A. 46-137a, *and amendments thereto,* during such
25 session shall be limited to the amount equal to the combined total actual
26 subsistence expenses incurred in Topeka and in out-of-state travel. The
27 provisions of the third sentence of K.S.A. 75-4606, *and amendments*
28 *thereto,* shall not apply to any legislator, and any legislator may use a
29 privately owned motor vehicle and receive reimbursement for mileage at
30 the rate provided in K.S.A. 75-3203a, and amendments thereto, whether
31 traveling under authority of such statute or this act.

32 Sec. 5. *{2.}* K.S.A. 46-137e, 46-157 and 75-3212 and K.S.A. 2015-
33 Supp. 46-137a are *{is}* hereby repealed.
