1 AN ACT ***concerning roads and highways***; ~~designating a portion of K-96~~
2 ~~as the George Ablah expressway~~; ***the Kenneth W Bernard memorial***
3 ***highway***; amending ***K.S.A. 68-1034 and K.S.A. 2014 Supp. 68-10,106***
4 ~~and repealing the existing section sections.~~

6 *Be it enacted by the Legislature of the State of Kansas:*

7 New Section 1. The portion of K-96 highway from the junction with
8 interstate highway 135 then east to the junction with Rock Road in
9 Sedgwick county is hereby designated as the George Ablah expressway.
10 The secretary of transportation shall place markers along the highway
11 right-of-way at proper intervals to indicate that the highway is the George
12 Ablah expressway, except that such signs shall not be placed until the
13 secretary has received sufficient moneys from gifts and donations to
14 reimburse the secretary for the cost of placing such signs and an additional
15 50% of the initial cost to defray future maintenance or replacement costs
16 of such signs. The secretary of transportation may accept and administer
17 gifts and donations to aid in obtaining and installing suitable signs.

18 Sec. 2. K.S.A. 2014 Supp. 68-10,106 is hereby amended to read as
19 follows: 68-10,106. The portion of K-96 highway from the junction with
20 ~~interstate highway 135~~ *Rock Road in Sedgwick county* then east to the
21 junction with interstate highway 35 is hereby designated as the Bonnie
22 Huy memorial highway. The secretary of transportation shall place
23 markers along the highway right-of-way at proper intervals to indicate that
24 the highway is the Bonnie Huy memorial highway, except that such signs
25 shall not be placed until the secretary has received sufficient moneys from
26 gifts and donations to reimburse the secretary for the cost of placing such
27 signs and an additional 50% of the initial cost to defray future maintenance
28 or replacement costs of such signs. The secretary of transportation may
29 accept and administer gifts and donations to aid in obtaining and installing
30 suitable signs.

31 *New Sec. 3. That portion of K-7 highway from the southern city*
32 *limits of the city of Lansing then north on K-7 highway to the northern*
33 *city limits of the city of Lansing is hereby designated as the Kenneth W*
34 *Bernard memorial highway. The secretary of transportation shall place*
35 *highway signs along the highway right-of-way at proper intervals to*
36 *indicate that the highway is the Kenneth W Bernard memorial highway,*

1 *except that such signs shall not be placed until the secretary has received*
2 *sufficient moneys from gifts and donations to reimburse the secretary*
3 *for the cost of placing such signs and an additional 50% of the initial*
4 *cost to defray future maintenance or replacement costs of such signs.*
5 *The secretary of transportation may accept and administer gifts and*
6 *donations to aid in obtaining and installing suitable signs.*

7 *Sec. 4. K.S.A. 68-1034 is hereby amended to read as follows: 68-*
8 *1034. From the junction of United States highway 24 and United States*
9 *highway 40 with United States highway 73 and highway K-7, United*
10 *States highway 73 and highway K-7 north to the southern city limits of*
11 *Lansing, then north from the northern city limits of Lansing to the eastern*
12 *junction with United States highway 59 in the city of Atchison, United*
13 *States highway 73 west to the junction with United States highway 159,*
14 *is hereby designated as the Amelia Earhart memorial highway. The*
15 *secretary of transportation shall place markers along the highway right-*
16 *of-way at proper intervals to indicate that the highway is the Amelia*
17 *Earhart memorial highway. The secretary of transportation may accept*
18 *and administer gifts and donations to aid in obtaining suitable highway*
19 *signs bearing the proper approved inscription.*
