2015 Session Deadlines

The following dates are the deadlines for introduction and consideration of bills for the 2015 session. These dates were adopted as part of the Joint Rules of the Senate and House of Representatives.

Monday, January 12th

First day of 2015 session; convene at 2:00 p.m.

Monday, February 2nd

Last day for <u>member</u> or <u>members</u> to submit <u>REQUESTS</u> to Revisor's office for bill drafts.

Monday, February 9th

Last day for <u>Committees</u>, except House and Senate Federal and State Affairs, Senate Ways and Means, Senate Assessment and Taxation, House committees on Calendar and Printing, Appropriations, Taxation or select committees of either house when so authorized, to submit <u>REQUESTS</u> to Revisor's office for bill drafts.

Wednesday, February 11th

Last day for <u>Individuals</u> to <u>INTRODUCE</u> bills in originating chamber.

Friday, February 13th

Last day for <u>Committees</u>, except committees listed above, to <u>INTRODUCE</u> bills in originating chamber.

Friday, February 27th (Turnaround Day)

Last day to <u>CONSIDER BILLS IN HOUSE OF ORIGIN</u>, except by House and Senate Federal and State Affairs, Senate Ways and Means, Senate Assessment and Taxation, House committees on Calendar and Printing, Appropriations, Taxation or select committees of either house when so authorized.

Wednesday, March 25th

Last day to <u>CONSIDER BILLS NOT IN HOUSE OF ORIGIN</u>, except by committees listed above.

Friday, April 3rd (Drop Dead Day)

No bills considered after this date except <u>BILLS VETOED BY</u> <u>GOVERNOR, OMNIBUS APPROPRIATIONS ACT AND OMNIBUS RECONCILIATIONS SPENDING LIMIT BILL</u>.

Veto session is anticipated to begin on Wednesday, <u>April 29th</u>, Sine Die-to be announced.
