2017 House Bill No. 2426, Reconciling Amendments to Certain Statutes

2017 House Bill No. 2426 reconciles amendments to certain statutes which have been amended more than once during the prior or current legislative sessions. The purpose of the reconciliation bill is to combine non-contradictory amendments from enacted legislation to produce one version of the statute. Without reconciling amendments, two versions of the statue will exist.

## Amendatory Sections for Statutes Amended More than Once

**Section 1**. K.S.A. 2016 Supp. 12-4117 was amended twice during the 2016 session and reconciles a conflict with K.S.A. 2016 Supp. 12-4117b. Municipal court assessments.

**Section 2**. K.S.A. 2016 Supp. 12-4516 was amended twice during the 2016 session and reconciles a conflict with K.S.A. 2016 Supp. 12-4516e. Expungement of certain convictions, arrest records and diversion agreements.

Section 3. K.S.A. 2016 Supp. 22-4903 was amended twice during the 2016 session and reconciles a conflict with K.S.A. 2016 Supp. 12-4903a. Violation of Kansas Offender Registration Act; aggravated violation; penalties; new and separate offense; prosecution, venue.

Section 4. K.S.A. 2016 Supp. 65-4202, as amended by section 22 of the 2017 House Bill No.

2055 was amended twice during the 2017 session and reconciles a conflict with K.S.A. 2016



Supp. 65-4202, as amended by section 3 of 2017 House Bill No. 2025. Definitions for the Mental Health Technician's Licensure Act.

**Section 5**. K.S.A. 2016 Supp. 65-6111 was amended twice during the 2016 session and reconciles a conflict with K.S.A. 2016 Supp. 65-6111a. Powers and duties of emergency medical services board; rules and regulations; temporary variances; imposition of fines; issuance of subpoenas; reporting requirements.

# Additional sections that have been recently signed into law

- K.S.A. 2016 Supp. 8-135 was amended twice during the 2017 Session in Senate Bill No. 36 and Senate Bill No. 89. Transfer of ownership of vehicles; registration; fees and penalties; certificate of title, form, fee.
- K.S.A. 2016 Supp. 12-4120 was amended twice during the 2017 Session in House Substitute for Senate Bill No. 40 and Senate Bill No. 89. Certain fines remitted to state treasurer; community corrections supervision fund; human trafficking victim assistance fund.
- K.S.A. 2016 Supp. 21-6614 was amended three times during the 2017 Session in House Substitute for Senate Bill No. 40, House Bill No. 2041, and House Bill No. 2085. Expungement of certain convictions, arrest records and diversion agreements.
- K.S.A. 2016 Supp. 22-2410 was amended twice during the 2017 Session in Senate Bill No. 112 and House Bill No. 2041. Expungement of arrest records; docket fee; disclosure limited upon filing of petition.
- K.S.A. 2016 Supp. 22-3717 was amended twice during the 2017 Session in House Substitute for Senate Bill No. 40 and Senate Bill No. 112. Parole or postrelease supervision; eligibility; interviews, notices and hearings; rules and regulations; conditions of parole or postrelease supervision.
- K.S.A. 38-2312 was amended twice during the 2017 Session in House Substitute for Senate Bill No. 40 and House Bill No. 2041. Expungement of records; docket fee.
- K.S.A. 74-7305 was amended twice during the 2017 Session in House Substitute for Senate Bill No. 40 and House Substitute for Senate Bill No. 101. Claims for compensation; application; conditions; limitations; amount.



### Repealed Only Sections

When different bills incorporate amendments to the same statute, one version of the bill or statute must be repealed to resolve having two versions of the same statute. 2017 House Bill No. 2426 addresses this issue by repealing one duplicative statute in section 6.
