1 AN ACT concerning certain claims against the state, making

3 restrictions and limitations, and directing or authorizing certain
4 disbursements, procedures and acts incidental to the foregoing.

6 *Be it enacted by the Legislature of the State of Kansas:*

24 accounts and reports is hereby authorized and directed to draw warrants on
25 the state treasurer in favor of the claimants specified in this act, upon
26 vouchers duly executed by the state agencies directed to pay the amounts
27 specified in such sections to the claimants or their legal representatives or
28 duly authorized agents, as provided by law.

29 (b) The director of accounts and reports shall secure prior to the
30 payment of any amount to any claimant, other than amounts authorized to
31 be paid pursuant to section 4, as motor-vehicle fuel tax refunds or as
32 transactions between state agencies as provided by this act, a written
33 release and satisfaction of all claims and rights against the state of Kansas
34 and any agencies, officers and employees of the state of Kansas regarding
35 their respective claims.
