Testimony in Support of House Bill 2639  
House Children and Seniors Committee

Chair Davis and Members of the Committee

Thank you for considering House Bill 2639, which would allow Kansas to continue to implement fingerprint-based criminal background checks for child care providers. Promoting safe child care environments is a critical component of making Kansas the best state to raise a child and to be a child. Kansas has a strong commitment to safe early childhood settings, including the passage of Lexie's Law in 2010. Facilitating the payment of fees for fingerprint-based background checks will ensure Kansas can implement policies to reduce the risk of abuse and neglect to children in child care while maintaining compliance with federal law.

**Conducting fingerprint-based background checks on individuals who work in child care facilities ensures greater safety for Kansas children.** Last year, this Committee supported and the Legislature passed legislation to expand the criminal penalties that disqualify persons from residing, working, or regularly volunteering at Kansas child care facilities. House Bill 2639 builds on that work to allow the implementation of policies intended to protect Kansas children in regulated child care.

**Implementing comprehensive, fingerprint-based background checks keeps Kansas in compliance with the federal Child Care and Development Block Grant, which is a major source of funding for child care services in the state.** In 2014, Congress passed a bipartisan reauthorization of the federal child care legislation, creating the opportunity for states to improve child care licensing policies. Federal law permits states to charge providers a fee for costs associated with processing required background checks, but it prohibits states from charging more than the actual cost of performing the check. If they choose, states may use federal funds to pay background check fees for child care providers. Facilitating the implementation of these fingerprint-based background checks is an important step to ensure Kansas continues to receive federal funding
