Testimony

RE: Testimony on SB 89

Mr. Chairman and Members of the House Transportation Committee:

My name is Kent Selk with the Division of Vehicles. I am presenting this testimony today in place of Deann Williams as she is attending a conference out of town. The division is in support of Senate Bill 89.

The Commercial Motor Vehicle Office is responsible for the registration of intrastate commercial motor vehicles (CMV) and the registration of vehicles that operate under the International Registration Plan (IRP). IRP vehicles operate in two or more jurisdictions.

Currently, the motor carrier has the choice of going to any one of the 10 regional offices for IRP/CMV registration which includes the Kansas Motor Carrier Services. If it is an intrastate CMV registration they can go to the closest CMV office that offers the services (a list of those offices is attached). Some motor carriers continue to mail their paperwork to the CMV Office located in Topeka which requires that CMV Office staff process the registration work.

In accordance with K.S.A. 8-135, 8-145 and 8-145d as currently written, the county treasurer is the sole recipient of the fees associated with commercial vehicle registration and even though the CMV staff are completing the registration work, the Kansas Department of Revenue is unable to retain the administrative fees intended to cover associated operating costs. Therefore, the CMV Office is requesting the ability to retain the fees for the work that is done by CMV staff by requesting amending the above-mentioned statutes, adding "division and contractor" to allow the entity completing the work to retain the associated administrative fees.

Allowing DOV to retain the fees associated with registrations processed by the CMV office will provide funding needed to maintain and enhance registration systems.
