Re: Responses to Law Enforcement Dash and Body Camera Survey

At its October 23, 2018, meeting, the Joint Committee requested staff work with law enforcement organizations to survey Kansas law enforcement agencies regarding the use of dash and body cameras and impact of recent legislation. With technical support from the Legislative Division of Post Audit (LPA), the Kansas Legislative Research Department (KLRD) developed a set of survey questions (attached) that a representative of the law enforcement organizations then distributed *via* their contact lists. Summaries of the responses are provided below. A spreadsheet with the complete responses and a list of other information provided by respondents are also attached.

Because completion of the survey was voluntary, the responses cannot be extrapolated to estimate statewide usage among all law enforcement agencies.

ALL LOCAL RESPONSES

A total of 143 responses were received from non-statewide agencies. Of these, 57 responses (39.9 percent) were from city agencies, 80 responses (55.9 percent) were from county agencies, 4 responses (2.8 percent) were from university agencies, 1 response was from a tribal agency, and 1 response was from a school district.

Seventy-two responses (50.3 percent) were received from agencies with 1-10 officers, 26 responses (18.2 percent) from agencies with 11-25 officers, and 35 responses (24.5 percent) from agencies with more than 25 officers.

Current Usage

Out of all responses, 90 (62.9 percent) indicated current use of body and dash cameras, 24 (16.8 percent) indicated current use of body cameras only, 19 (13.3 percent) indicated current use of dash cameras only, and 10 (7.0 percent) indicated no current use of either body or dash cameras. Thus, a total of 133 (93.0 percent) indicated use of at least one type of camera. Of those agencies indicating no current camera use, 2 indicated they plan to begin implementing body cameras within the next year.

Of those 133 agencies indicating use of at least one type of camera, 41 (30.8 percent) indicated they have guidelines requiring use at all interactions with the public, 65 (48.9 percent) indicated they have guidelines requiring use at selected interactions with the public, 17 (12.8 percent) indicated they have guidelines allowing use at the officer's discretion, and 10 (7.5 percent) indicated they have no current guidelines. Of the 10 agencies with no current guidelines, 6 agencies indicated they are working toward developing such a policy.


Cost, Number of Cameras, and Approximate Annual Cost of Storage

Viewing Requests

Of the agencies utilizing body or vehicle video, 29 indicated they had received requests since July 1, 2018, requiring viewing within 20 days of the request. Eighty-five indicated they had not received such requests.

Respondent Comments

Respondents also were asked to provide any other information they felt was relevant to their agencies' use of body and dash cameras. The comments provided in response are attached to this memorandum.

STATE AGENCY INFORMATION

State agencies identified as possibly employing law enforcement officers (as defined in KSA 74-5602) were contacted separately with a similar e-mail survey.

Responses were received from the Kansas Bureau of Investigation, Adjutant General's Department, Department of Labor, Kansas Lottery, and Kansas Highway Patrol (KHP). The KHP indicated the agency currently utilizes dash cameras and their guidelines require use at all interactions with the public. The approximate cost to implement KHP's video system was \$2,215,220, which includes 460 cameras. The KHP has not received any request since July 1, 2018, requiring viewing within 20 days of the request.

All other responding state agencies indicated they do not currently utilize either type of camera and do not plan to implement either type of camera within the next year.

[Note: Responses have been lightly edited for some capitalization and obvious typos.]

- It is a very valuable tool. In most cases these cameras capture law enforcement doing the right thing. In those cases where law enforcement was in the wrong we are able to quickly address those issues. We are also able to quickly dispel false accusations against our employees.
- Both the body cam video as well as the In-Car camera footage has given me clear evidence during several incidents that my officers did everything correct. The Complaints went unfounded with certainty.
- This is only a tool that gives one perspective and may not document everything. To much weight is being placed on the video.
- Implementation of body and mobile camera equipment and operation presented numerous issues and difficulties, and was frequently frustrating. We purchased the top of line and newest technology product available from a well known vendor/brand as was possible, and had their techs professionally install all our units and systems. In our first six months of deployment, there wasn't a single week that there wasn't either one or multiple units, mobile or body, that were inoperable or failed to work properly. Issues came from operator errors, equipment malfunctions, programming issues, partner software conflicts, network conflicts, and a variety of other areas of logistics. In that first 6 months, there were a number of incidents and events that were not recorded, due to these prevailing issues and areas. Prosecutors, defense attorneys and stakeholders were not very understanding, or pleased that there were no recordings in these incidents and events, and cases were impacted. The second six months was better with less major failures and issues occurring, but there have still been plenty of equipment failures and various logistic conflicts, that have occurred. We are now entering the second year of deployment and have suspended purchasing any additional units/systems to fill out our full compliment of vehicles and officers, until we can reach a level of satisfaction with the equipment, service and operational reliability. Contractual agreements at the onset of the purchase and implementation of the systems dictated that every and all opportunities be afforded the vendor to resolve any issues and matters with the equipment and its operations, and failure to do so breaches the warranties and liabilities of the vendor. To the vendor's credit, they have been responsive to identify, address, and work on resolving the issues as they occur, and recently the frequency of failures has been reduced. Time will tell how we will proceed in the future. While the use of body and dash cams is beneficial to law enforcement and the public in helping to document some of the details of an incident, I greatly fear that the public, society, the courts and others, as a whole are taking the position that video recordings are the absolute foundation of the truth and details of an event, irregardless of any officers and witnesses testimony and other presence of evidence. Video, much like photos may be perceived inaccurately by the viewer and may not always reflect or tell other aspects of the event. Body and mobile cameras are good tools to have, but they are no the only tool necessary, nor the only tool needed to do our jobs and fulfill our mission.
- Failure rate on BWC [body-worn cameras] has been relatively high

- In any legislation it will be important to address attempts by those allowed to view the video to record the video using a cell phone or other device.
- BWC/In Car is a necessity but we feel strongly that its governance should be at the local level.
- "Hidden" costs are VERY expensive; even more than the equipment costs. The biggest cost is I.T. personnel costs to maintain the system, and records personnel costs to process the video for requests. I'm 100% in favor of video cameras, but if the State chooses to msndayectgem [sic], they MUST provide funding to go with the mandate!
- This agency has had in car cameras since the mid 90's and Body Worn Cameras since 2012
- Related to the request to release video within 20 days, we have had one. It was from an attorney. We have had about 50 other video requests since July 1, 2018 and none of those requested or mentioned the 20 day requirement. We were able to provide KORA video within the 20 days in all cases.
- Storage costs are significant and will continue to get more expensive!
- Our in-car and BWC system is from the same manufacturer. The recordings are linked together which helps with achieves. Everyone from line officers to Chief loves our recording system. Very few problems have occurred and they do a great job of recording the incidents.
- Love the camera but forget to turn it on or off.
- They are very costly, but has saved at least three officers from false allegations. Even though the costs were so high, it set our department budget back tremendously I feel it is well worth it.
- VERY EXPENSIVE PIECE OF EQUIPMENT, CANT AFFORD TO KEEP UP TO DATE.
- Considering body cameras, but the cost of data storage and time spent managing storage are holding process back.
- We do use dash cameras and are in the process of going through an RFP process to purchase BWC's.
- We have a draft policy we are working on for BWC that I will send but we are still tweaking it as we move closer to purchase of the BWC's.
- Quite expensive to maintain. but very nice to prove or disprove complaints
- The body cam who is useful in the squashing an allegation about one of my officers. I reviewed the video and contacted the subject with the complaint and advised her that I seen no rude, vulgar or abusive action on my deputies behalf. I informed her that if she or her attorney wanted a copy of the video it would be at their disposal. I believe when she discovered there was a body

camera she had no Interest to pursue any further action.

- No current policy on retention of videos
- Cost of service agreements and storage and software updates are outrageous in price.
- We have had a lot of technical difficulty with them and have had them only about 3 years. They do help with less court time because of the evidence they do provide. The defendants plea much faster.
- These numbers and cost include our Patrol Division only. We also utilize 8-10 body cams in our Correctional Facility.
- We have also provided our Jail Staff with Body Cameras
- The evidence provided by body cameras is excellent, however should viewing requests become common it will place a major burden on our staff.
- Great tool for officers and public alike. We have adopted use in jail and false complaints from inmates have dropped significantly. Disputes are quickly and easily resolved.
- Complete monitoring such as continuous record would place undue stress on officers. Their personal interactions are not subject to public speculation as well as those they interact with.
- Initial cost is only the beginning. Annual cost of storage and replacement as equipment ages will continue to be an issue for departments regardless of size.
- Our agency is consistently evaluating the use of the our body and dash cameras for effectively law enforcement.
- Critical part of day to day operation to protect the public and law enforcement and police the public and law enforcement
- Not all officers have body cams. we are trying to get cameras for everyone as funds become available
- Atty's [Attorneys] are issuing business subpoena to obtain video instead of asking through discovery
- I believe they should never be allowed to be an open public record. I understand if those on the video wish to see them at our convienance but the video shows people personal home's as to what they have within their home if they keep a clean or dirty house and the lay out of the house and sometime the persons have little to no cloths on. It would be a invasion of privacy in my opinion. Body and Dash Cams should be used for evidence purposes only and for the protection of the citizen and officer when the are in contact with each other for any reason
- POV is the only way to go on body cams

- I would prefer utilizing both body & car cameras if funding was available.
- I do not want any other agency to have any say in what is done with the video or lack there of. It should not be mandatory to have cameras although they are helpful in many cases.
- The recent legislative changes regarding viewing by outside parties is a workable solution for everyone. Tell the legislature to leave well enough alone.
- Each Patrol car has one and when you turn on your red lights the camera starts automatic each car stop or any family disputes etc.
