Rep. Ballard/Barbara, thank you for your questions today following up on the survey issue. Here is the information (see below) on delays to survey that Secretary Keck sent to me on Oct. 15th. You'll see the range has been from a low of 17.68 months in Sept. and a high of 23.85 months in June 2018.

This is too long between annual health surveys to effectively protect health and safety for frail elders in nursing facilities. When KDADS goes in to investigate/survey based upon a complaint instead when they do a full annual health survey, inspectors are there for 1-2 days (rather than a week), with fewer surveyors (1 or 2 instead of 4-5), and surveyors are directed to look at only the things which were part of the complaint. So KDADS sometimes says they are in surveying more frequently — but it is for these limited and specific complaint surveys.

And what the new projected date is for compliance with the required on-average 12 month inspection across all nursing facilities as opposed to the 15 month frequency for any single facility (you had suggested August 2019 at an August stakeholder meeting I attended). Is this related to surveyor hiring/lack of hiring?

And could you please clarify the action CMS took with regard to the State – amount of money, fine or withheld reimbursement for inspectors/inspection costs, will/has the State recover/ed that money, and the reason for the financial withholding or fine.
