SENATE BILL No. 100

AN ACT concerning the nursing service scholarship program; scholarships for mental health nurses; amending K.S.A. 74-3292, 74-3293, 74-3294 and 74-3297 and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

K.S.A. 74-3292 is hereby amended to read as follows: 74-3292. As used in this act: Section 1.

"Committee" means the nursing service scholarship review committee established under K.S.A. 74-3299, and amendments thereto.

"Executive officer" means the chief executive officer of the state board of regents appointed under K.S.A. 74-3203a, and amendments thereto.

"Mental health or treatment facility" means: <u>ပ</u>

Any private treatment facility as such term is defined in K.S.A. 59-29b46, and amendments thereto; any public treatment facility as such term is defined in K.S.A. 59-29b46, and amendments thereto;

any community mental health center organized pursuant to the and licensed pursuant to K.S.A. 2016 Supp. 39-2001 et seq., and provisions of K.S.A. 19-4001 through 19-4015, and amendments thereto, amendments thereto; \mathfrak{S}

(6) any hospital as defined in K.S.A. 65-425, and amendments thereto, provided: (A) The hospital has a psychiatric unit; and (B) the scholarship recipient is required to fulfill the nursing service scholarship's employment obligations as an employee in the psychiatric unit of the hospital; or

(4) (e) "School of nursing" means a school within the state of Kansas which is approved by the state board of nursing to grant an associate degree or a baccalaureate degree in professional nursing or a certificate of completion in practical nursing and is:

- (1) Under the control and supervision of the state board of regents;

(3) a not-for-profit independent institution of higher education that has its main campus or principal place of operation in Kansas, maintains open enrollment as such term is defined in K.S.A. 74-32,120, and amendments thereto, and is operated independently and not controlled or administered by the state or any agency or subdivision thereof.

(e) (f) "Sponsor" means any adult care home licensed under the adult care home licensure act, any medical care facility licensed under K.S.A. 65-425 et seq., and amendments thereto, any psychiatric hospital licensed under K.S.A. 75-3307b, and amendments thereto, any home health agency licensed under K.S.A. 65-5101 et seq., and amendments thereto, any local health department as defined in K.S.A. 65-241, and amendments thereto, any mental health or treatment facility and any state agency which employs licensed practical nurses or licensed professional nurses.

(1) The name and address of the applicant;

the name and address of the school of nursing in which the applicant is enrolled or to which the applicant has been admitted;

the name and address of the sponsor of the applicant and a verified copy of the agreement entered into by the applicant and the sponsor in accordance with the provisions of the nursing service scholarship program; and

- any additional information which may be required by the executive officer.
- (b) As a condition to awarding a scholarship under the nursing service scholarship program, the executive officer and the applicant for a scholarship shall enter into an agreement which shall require that the scholarship recipient:
- (1) Complete the required course of instruction and attain licensure with the Kansas state board of nursing as a licensed professional nurse or a

- (4) maintain records and make reports to the executive officer as may be required by the executive officer to document the satisfaction of the obligations under the nursing service scholarship program and under agreements entered into with the sponsor; and
