Mr. Chairman and Members of the Committee, good morning. My name is Hans Asmussen, and I am a member of Kansas Fraternal Order of Police Lodge Number 5 Wichita, Kansas.

There were 21 ambush-style killings of Police Officers across the country in 2016. This is 21 out of 64 gunshot related deaths that year. According to the National Law Enforcement Officers Memorial Fund, ambush-style killings are the highest they have been in 2 decades. Let that sit for a few moments.

This means that at a minimum 21 Officers paid the ultimate price for the safety and security of others. They were murdered for nothing more than the one simple fact: They wore a badge, and swore an oath with their lives, to protect each and every one of us. We have seen in recent times, like in Florida, Texas, and many other places, photos of the brave men and women behind the badge running towards danger. Also in these photos we see countless officers using their bodies to shield civilians from harm.

While there are laws in place to punish those who commit the heinous crimes of physically attacking or killing an on-duty law enforcement officer, there are countless other Officers who are the victims of other crimes for the same reason: wearing a badge. The offenders in these cases are charged the same, regardless of their victim. So what is in place to protect those who protect us? Nothing at this current time. I know personally of an Officer in Wichita, KS who arrested a suspect for numerous crimes. During booking, the arrestee threatened to kill the officer when he was released from jail. This isn't something that is all that uncommon and shockingly we are used to that. The arrestee then took it further, he noticed that the Officer was wearing a wedding ring. The arrestee then went on to say that he was going to look up where the officer lives and rape and kill his wife. In another incident, a subject shot at a police car parked in front of the police officers house. Bullets went into the garage and struck the officer's personal vehicle. Video evidence showed that the suspect targeted the house because a police officer lived there. What was the motivation behind these? It's a simple answer: because our officers wear a badge.
