I move to amend **HB 2038**, on page 1, in line 16, after "(B)" by inserting "(i)"; in line 17, after "forces" by inserting "; or (ii) law enforcement officer"; in line 19, before "Such" by inserting ""Law enforcement officer" shall mean any law enforcement officer, as defined in K.S.A. 74-5602(g), and amendments thereto: (A) Who has been certified as a Kansas law enforcement officer under the Kansas law enforcement training act, K.S.A. 74-5601 et seq., and amendments thereto, for a minimum of 10 years; or (B) is receiving disability benefits for a duty-related injury."; in line 28, after "(B)" by inserting "(i)"; in line 29, after "forces" by inserting "; or (ii) law enforcement officer"; in line 31, before "Such" by inserting ""Law enforcement officer" shall mean any law enforcement officer, as defined in K.S.A. 74-5602(g), and amendments thereto: (A) Who has been certified as a Kansas law enforcement officer under the Kansas law enforcement training act, K.S.A. 74-5601 et seq., and amendments thereto, for a minimum of 10 years; or (B) is receiving disability benefits for a duty-related injury.";

On page 3, in line 31, after "(B)" by inserting "(i)"; also in line 31, after "forces" by inserting "; or (ii) law enforcement officer"; in line 33, before "Such" by inserting ""Law enforcement officer" shall mean any law enforcement officer, as defined in K.S.A. 74-5602(g), and amendments thereto: (A) Who has been certified as a Kansas law enforcement officer under the Kansas law enforcement training act, K.S.A. 74-5601 et seq., and amendments thereto, for a minimum of 10 years; or (B) is receiving disability benefits for a duty-related injury.";

On page 4, in line 36, after "(B)" by inserting "(i)"; in line 37, after "forces" by inserting "; or (ii) law enforcement officer"; in line 39, before "Such" by inserting ""Law enforcement officer" shall
