SUBJECT: Fiscal Note for SB 4 by Legislative Post Audit Committee

In accordance with KSA 75-3715a, the following fiscal note concerning SB 4 is respectfully submitted to your committee.

Under current law, proceeds deposited into state forfeiture funds of the Kansas Bureau of Investigation, the Kansas Highway Patrol, the Department of Corrections; local government special law enforcement trust funds; and the Counter Drug State Enforcement Fund of the Kansas National Guard must not be used for normal operating expenses. SB 4 would specify that normal operating expenses would include salaries, benefits or salary enhancements for permanent employees.

The Kansas Highway Patrol indicates that state forfeiture funds are used to pay for the salary and benefits of an Asset Forfeiture Coordinator position. For FY 2017, this is permitted by law through an appropriations bill proviso in Section 151(a) of Chapter 104 of the 2015 Session Laws of Kansas that allows funds to be used for the salaries and wages expenditures of non-supervisory personnel. If the proviso is excluded from future appropriations bills, passage of SB 4 would require the Kansas Highway Patrol to shift the costs of the Asset Forfeiture Coordinator position from the agency's state forfeiture fund to the Kansas Highway Patrol Operations Fund. Expenditures for this position are \$71,739 in FY 2018 and \$73,891 in FY 2019.

According to the League of Kansas Municipalities, some cities use special law enforcement trust funds to pay for the salaries and wages expenditures of ad hoc law enforcement task forces. SB 4 would require certain cities to reduce expenditures associated with ad hoc task forces or find other sources of municipal funding. However, the League is unable to estimate the specific fiscal effect from the bill because it does not possess financial data on all local law enforcement agencies in Kansas.

The Kansas Bureau of Investigation, the Department of Corrections and the Adjutant General report that the bill would have no fiscal effect on their respective agencies because they do not use state forfeiture funds for salary and wages expenditures. The Kansas Association of Counties indicates that there would be no fiscal effect on local governments. Any fiscal effect associated with SB 4 is not reflected in *The FY 2018 Governor's Budget Report*.
