### SUPPLEMENTAL NOTE ON HOUSE BILL NO. 2093

#### As Amended by House Committee on Corrections and Juvenile Justice

# Brief\*

HB 2093 would amend statutes governing the determination of criminal history by adding that no juvenile adjudication for an offense which would be a non-drug severity level 5 through 10 felony, drug felony, non-grid felony, or misdemeanor if committed by an adult would be considered and scored if the current crime was committed at least five years after the final discharge of the adjudication and the offender has no new adjudications or convictions during that period.

# Background

The bill was introduced by the House Committee on Corrections and Juvenile Justice at the request of the Kansas Sentencing Commission. In the House Committee hearing, a representative of the Kansas Sentencing Commission testified in favor of the bill, and the Kansas Association of Criminal Defense Lawyers provided written testimony in favor of the bill. No neutral testimony was presented. A representative of the Kansas County and District Attorneys Association testified in opposition to the bill.

The House Committee made a technical amendment to the bill.

According to the fiscal note on the bill prepared by the Division of the Budget, the Kansas Sentencing Commission determined the bill may affect adult prison beds and the agency's workload, but the Commission could not provide a precise estimate.
