I, Donna Lippoldt, was the head of the ministry that stood in front of George Tiller's Abortion Clinic for 18 years. I was there 2-3 times a week for 18 years. I organized prayer vigils, worship services, and tried, successfully to talk to women and men going into that place. Thousands of whom changed their minds as soon as they knew there were options. I could tell you countless stories of women who felt alone, nowhere to turn, abandoned by the father, who were overwhelmed and just needed someone to tell them it was worth it all. We connected them to resources, churches, and people who didn't want their money but wanted to do whatever they could to give them a choice not to kill their baby.

As believers in life from fertilization to natural death stood there in rain, hail, snow, and heat there were many times when Mr. Tiller would crank up the crematorium. The stench and ashes went throughout the city. The abortion clinic was directly south of the V.A. In the 90's I often wondered if the veterans of WW II recognized the smell ((It may be a strong comment to suggest that of all the senses, smell is most closely related to memory- it's true.) and could almost hear the cries of the Jews during the Holocaust. Now, we had a holocaust right in Kansas. As those who believe that little baby boys and girls should live and not die came to join in prayer, they would be crying, saddened that once again, children were being murdered and their ashes falling on us, our cars and our city. In Germany even some believers in Christ ignored the cries of these infants in our hearts and minds.

We were there when we knew that George Tiller was selling baby parts. They would take the parts out in iced coolers UPS and Fed X did the shipping. The brain was worth \$999. At that time the spinal cord \$325., Bone Marrow, \$350, Ears \$75. I have a copy of the baby parts price list and will provide this to any of you. The Baby Parts Price List was from a pathology and diagnostic company in West Frankfort, II. The opening line in the brochure said, "Turn your patients' decision into something wonderful."

New York has nothing on Kansas. Our legislature made it legal to kill little baby boys and girls right up until the time of delivery decades ago. We recognize that there have been bills passed in the last few years to curb this, but one death is too many. It only seems right that Kansas would be the state that sends Personhood to the Supreme Court since we had the best-known late term abortion provider in the nation. I would meet people from all over the world coming up the sidewalk of the clinic. Women who really looked like they should be driven to the hospital for delivery, but walked into see him, he would insert Laminaria and gradually over a period of days the cervix would open until they could deliver, hopefully back at the clinic, but many times into the toilet at the hotel.

President Trump's administration, HHS says life begins at conception. End of discussion. When we first began to present Personhood as the best option, the objections were in regard to the Supreme Court of the United States. Now, we've seen a shift there. There is once again the possibility that we can remove this curse from our nation. NOW, more than ever, with the acceleration of death even after one survives an abortion, we must take the PERSONHOOD stand, or suffer the consequences. We owe this to the future generations, we owe it to those heroes of the faith who are now watching from above who stood their ground and fought for life.

You would agree I suppose that one of the important factors that needs to be considered in this case is what rights if any does the unborn fetus have?
