In-Person Testimony – proponent SB 551

Senator Kerschen and Members of the Committee:

My name is Jasmine Kyle. I am the director of the SEK Humane Society, a Pittsburg-based nonprofit organization and a licensee under the Kansas Pet Animal Act (KPAA). Today, I am speaking as part of a coalition of shelters and rescues that strongly supports SB 551, which would establish a stand-alone Pet Animal Facilities Inspection Division at the Kansas Department of Agriculture.

In a 2011 Executive Order, Governor Sam Brownback eliminated the Kansas Animal Health Department (KAHD), an independent state agency for 127 years, and merged it into the Kansas Department of Agriculture. At that time, the Animal Facilities Inspection (AFI) program, responsible for enforcing the Pet Animal Act, was moved to the Kansas Department of Agriculture's Animal Health Division.

Prior to the merger, the Pet Animal Act was effectively enforced, resulting in the closure of 20-45 licensed and unlicensed facilities and seizure of approximately 950 animals annually. Following the merger, the KDA sold equipment needed for seizures and has only facilitated two seizures of animals in need of care in the past decade.

A Legislative Post Audit (LPA) completed in December 2018 indicated that under the KDA, the cycle of inspection failures was allowed to continue without consequences and that animals "were allowed to suffer." Additionally, there was no longer an investigator position to find and close unlicensed animal facilities.

SB 551 will address the deficiencies identified in the LPA and support the work of shelters and rescues. To illustrate our support, shelters and rescues from across Kansas have signed onto the following resolution:

## **RESOLUTION IN SUPPORT OF SB 551**

WHEREAS,

• Senate Bill 551 creates a new Pet Animal Facilities Inspection Division within the Kansas Department to Agriculture, which provides a vital opportunity to protect Kansas pets, support the work of shelters and rescues, and meet the goals of the Kansas Department of Agriculture's Ag Growth Initiative;

The Animal Facilities Inspection (AFI) Program is currently housed in the Kansas Department of Agriculture's Division of Animal Health, whose primary focus is supporting the livestock industry and securing the safety of the state's food supply;

- The new Pet Animal Facilities Inspection Division will improve oversight of the Kansas Pet Animal Act;
- The 296 Kansas shelters and rescues care for the state's lost, homeless, and neglected pets;
- A 2018 Legislative Post Audit found that the AFI program lacked adequate policies to ensure consistent inspections and penalties under the Kansas Pet Animal Act;
- The program deficiencies have created an undue financial burden on local governments and local shelters that provide urgent care for animals seized by law enforcement; and
- SB 551 will support the efforts of shelters and rescues that, through adoption, training, and emergency services, protect pets and serve Kansas communities;

## NOW THEREFORE,

The undersigned urge the passage of SB 551 to protect Kansas pets and advance the state's image as a leader in pet animal health.
