2022 Session Deadlines

The following dates are the deadlines for introduction and consideration of bills for the 2022 session. These deadlines were adopted as part of the Joint Rules of the Senate and House of Representatives for the 2021-2022 biennium and are subject to change.

Monday, January 31st

Last day for <u>member</u> or <u>members</u> to REQUEST bill drafts from Revisor's office.

Monday, February 7th

Last day for <u>non-exempt Committees</u> to REQUEST bill drafts from the Revisor's office.

NOTE: This is the last day requests for introduction can be on nonexempt committee agendas.

Wednesday, February 9th

Last day for <u>Individuals</u> to INTRODUCE bills in originating chamber. NOTE: Bills must be submitted to chamber staff during daily session for Introduction.

Friday, February 11th

Last day for <u>non-exempt Committees</u> to INTRODUCE bills in originating chamber. NOTE: Bills must be submitted to chamber staff during daily session for Introduction.

Thursday, February 24th (Turnaround Day)

Last day to consider non-exempt bills in house of origin.

Wednesday, March 23rd (Second Chamber Consideration)

Last day to consider non-exempt bills not in originating chamber.

Friday, April 1st (First Adjournment)

No bills considered after this date except bills vetoed by governor, omnibus appropriations act and omnibus reconciliations spending limit bill.

Veto session is anticipated to begin on April 25th.

Exempt committees: House and Senate Federal and State Affairs, Senate Ways and Means, Senate Assessment and Taxation, House committees on Calendar and Printing, Appropriations, Taxation or select committees of either house when so authorized.

Exempt bills are those sponsored by, referred to or acted upon by an exempt committee.
