26	of accounts and reports is hereby authorized and directed to draw warrants
27	on the state treasurer in favor of the claimants specified in this act, upon
28	vouchers duly executed by the state agencies directed to pay the amounts
29	specified in such sections to the claimants or their legal representatives or
30	duly authorized agents, as provided by law.
31	(b) The director of accounts and reports shall secure prior to the
32	payment of any amount to any claimant, other than amounts authorized to
33	be paid pursuant to section—11 12 as motor-vehicle fuel tax refunds or as
34	transactions between state agencies as provided by this act, a written
35	release and satisfaction of all claims and rights against the state of Kansas
36	and any agencies, officers and employees of the state of Kansas regarding
37	their respective claims.

39	its publication in the Kansas register.
